ORDER IN COUNCIL

At the Government House at Wellington this 14th day of August 1972

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

---

REGULATIONS

1. **Title and commencement**—(1) These regulations may be cited as the Otago Inland Harbours Regulations 1969, Amendment No. 1, and shall be read together with and deemed part of the Otago Inland Harbours Regulations 1969\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the seventh day after the date of their notification in the *Gazette*.

2. **First Schedule amended**—The First Schedule to the principal regulations is hereby amended by omitting from the first column the words "Lake Hayes", and also by omitting from the second column the words "The waters of Lake Hayes."

3. **Second and Third Schedules substituted**—The principal regulations are hereby further amended by revoking the Second and Third Schedules thereto, and substituting the Second and Third Schedules set out in the Schedule hereto.

4. **Fourth Schedule amended**—The principal regulations are hereby further amended by omitting from the Fourth Schedule thereto the word "northernmost", and substituting the word "north-eastern", and also by omitting the word "southernmost", and substituting the word "south-eastern".

## "SECOND SCHEDULE

"Reg. 5

## "DESCRIPTION OF ACCESS LANE No. 1

"ALL that area of water in Queenstown Bay, Lake Wakatipu, contained within a rectangle, the south-eastern boundary of which is a line running in a 227° direction for 720 yards from a point which is 245 yards on a line running 137° from the south-eastern corner of the land shown on Deposited Plan No. 7254, being a subdivision of Part Sections 7 and 8, Block XXVII, Town of Queenstown, and the north-eastern boundary of which runs in a 317° direction for 125 yards from the aforesaid point.

"Marks—

"(a) At the northern corner, and at a position on the north-western boundary 395 yards from the northern corner, yellow and black barrel buoys fitted with yellow reflector strips:

"(b) At the eastern corner a red barrel buoy fitted with red reflector strips.

## "THIRD SCHEDULE

## "DESCRIPTION OF ACCESS LANE No. 2

"ALL that area of water in Queenstown Bay, Lake Wakatipu, contained within a rectangle, the south-eastern boundary of which is a line running in an 047° direction for 700 yards from the green-lighted beacon situated on the submerged reef 385 yards more or less westward of Scott Memorial, Queenstown, and the south-western boundary of which runs in a 317° direction for 125 yards from the said beacon.

"Marks—

"(a) At the northern corner, and at the western corner, red barrel buoys fitted with red reflector strips:

"(b) At the eastern corner a yellow barrel buoy fitted with yellow reflector strips:

"(c) The southern corner marked by the reef light flashing green."

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations amend the Otago Inland Harbour Regulations 1969. Lake Hayes is no longer declared to be a harbour. Certain minor alterations are made to access lanes in other Otago Inland Harbours.
