



**THE OCCUPATIONAL THERAPY REGULATIONS 1964,
AMENDMENT NO. 14**

ORDER IN COUNCIL

PURSUANT to section 32 (2) (e) of the Occupational Therapy Act 1949, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Occupational Therapy Regulations 1964, Amendment No. 14, and shall be read together with and deemed part of the Occupational Therapy Regulations 1964* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1993.

2. Fees—The principal regulations are hereby amended by revoking regulation 21 (as substituted by regulation 2 of the Occupational Therapy Regulations 1964, Amendment No. 13), and substituting the following regulation:

“21. (1) The fee for examination under section 10 (2) of the Act shall be \$400.00 except in the case of an examination conducted otherwise than by the Board and for which any other fee is payable by the applicant in which case no fee shall be payable under this subclause.

“(2) Subject to subclause (3) of this regulation, the fee for registration shall be \$155.00.

“(3) No fee shall be payable under subclause (2) of this regulation in the case of an application for registration by an applicant who is registered as an occupational therapist in any other country, and who is temporarily employed in a hospital in New Zealand on exchange for not more than 12 months with an occupational therapist who is registered in New Zealand, and who is not charged a fee for registration in that overseas country.

“(4) The fee for the issue of a certificate of registration shall be \$34.00.

“(5) The fee for the issue of an annual practising certificate shall \$120.00.

“(6) The fee for the restoration of a name to the register, pursuant to an application under section 16 (4) of the Act, shall be \$70.00.

“(7) The fee for the correction of a name in the register, pursuant to an application under section 18 (2) of the Act (not being a case to which the proviso to that subsection applies), shall be \$12.00.

“(8) The fee for supplying any document for the purpose of enabling an occupational therapist to seek registration outside New Zealand shall be \$34.00.”

3. Fees inclusive of goods and services tax—The fees fixed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

4. Revocation—The Occupational Therapy Regulations 1964, Amendment No. 13 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 1993, prescribe a new and increased scale of fees payable under the Occupational Therapy Act 1949.

The fees prescribed are inclusive of goods and services tax.
