**THE POST AND TELEGRAPH AMENDING REGULATIONS, 1936,
AMENDMENT NO. 2.**

Enacting authority : His Excellency the Governor-General in Council.
Act pursuant to which the regulations were made : Section 230 of the
Post and Telegraph Act, 1928, and all other powers enabling in
that behalf.

Date on which the regulations were made : 16th day of December, 1936.

Date of notification in *Gazette* : 22nd day of December, 1936.

REGULATIONS.

1. These regulations may be cited as the Post and Telegraph Amending Regulations, 1936, Amendment No. 2.*

2. These regulations shall be read together with and form part of the regulations under the Post and Telegraph Department Act, 1918, made by Order in Council and published in the *Gazette* of the 23rd December, 1925, at page 3460 (hereinafter called "the principal regulations").

3. These regulations shall come into force on the day following notification in the *Gazette* of the making hereof.

4. Regulation 70 (1) of the principal regulations is revoked, and the following substituted :—

70. (1) With the exception of the employees provided for in paragraph (2) of this regulation, every officer in the Department and every temporary employee, if circumstances should arise necessitating the retention of such employee in the Service for more than a year, may be granted annual leave of absence for recreation on the following scale :—

(a) If continuous service amounts to ten years or more, three weeks :

(b) If continuous service is less than ten years, two weeks :

(c) Message-boys, one week after one year's complete service.

For the purpose of this regulation the term "week" is defined to mean five working-days in the case of an officer usually working five days each week, and in the case of an officer usually working six days each week it is deemed to mean six working-days.

The granting of any such leave shall be subject to the express conditions that the conduct of the officer has been in every way satisfactory and that his official duties have been satisfactorily performed.

Where an officer has been absent on sick or special leave, whether with or without pay, exceeding thirty days in one or more periods in any leave year, the period of annual leave shall be reduced by one day for every thirty days (including Saturdays and Sundays) of such absence. In special cases the Director-General may grant further leave.

5. Regulation 70 (2) (a) of the principal regulations is revoked, and the following substituted :—

70. (2) (a) Temporary workmen with at least twelve months' continuous service may be granted one week's annual leave. Those with at least two years' continuous service may be granted two weeks' annual leave. In addition, leave of absence with pay may be granted in respect of the following days : Christmas Day, Boxing Day, New Year's Day, Good Friday, Easter Monday, the King's Birthday, Labour Day, and Anzac Day.

6. Regulation 70 (2) (b) of the principal regulations is hereby amended by revoking the words " Temporary workmen with not more than two years' service ", and inserting the words " Temporary workmen with less than twelve months' continuous service ".

7. Regulation 70 (3) of the principal regulations is hereby amended by revoking the words " thirty-six working-days ", and inserting the words " six weeks ".
