1 Title

This notice is the Penal Institutions (Hawke's Bay Regional Prison) Notice 2002.

## 2 Commencement

This notice takes effect from 26 September 2002.

# 3 Hawke's Bay Regional Prison

The land described in the Schedule is a prison, to be known as Hawke's Bay Regional Prison.

## 4 Revocation

The Penal Institutions (Hawke's Bay Regional Prison) Notice (No 2) 2001 (SR 2001/295) is revoked.

## **Explanatory note**

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which takes effect from 26 September 2002, is made under the Penal Institutions Act 1954. It declares the land described in the *Schedule* to be a prison, to be known as Hawke's Bay Regional Prison.

This notice replaces a 2001 notice relating to the prison. The only change is that the land described in the *Schedule* includes 1 additional parcel of land that was not part of the land that the previous notice declared to be the prison.
