

## THE PENAL INSTITUTIONS NOTICE 1986

PURSUANT to section 4 of the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

## NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Penal Institutions Notice 1986.
  - (2) This notice shall take effect from the 4th day of September 1986.
- 2. Waikeria Minimum Security Prison—The land described in the First Schedule to this notice, being part of the land comprising the penal institution known immediately before the date of the commencement of this notice as the Waikeria Youth Institution, is hereby declared to be a prison, to be known as the Waikeria Minimum Security Prison.
- **3. Waikeria Prison**—The land described in the Second Schedule to this notice, being the balance of the land comprising the penal institution known immediately before the date of the commencement of this notice as the Waikeria Youth Institution, is hereby declared to be a prison, to be known as the Waikeria prison.
- **4. Hawkes Bay Prison**—The land described in the Third Schedule to this notice is hereby declared to be a prison, to be known as the Hawkes Bay Prison.
- **5. Revocations and amendments**—(1) The following notices are hereby revoked:

  - (2) Clause 3 of the Penal Institutions Notice 1974 is hereby revoked.

## FIRST SCHEDULE

## WAIKERIA MEDIUM SECURITY PRISON
