THE PENAL INSTITUTIONS NOTICE (NO. 2) 1961

PURSUANT to the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

NOTICE

1. This notice may be cited as the Penal Institutions Notice (No. 2) 1961.

2. The land described in the First Schedule hereto is hereby added to and declared part of the Invercargill Borstal Institution.

3. The land described in the Second Schedule hereto is hereby declared to be a borstal institution to be known as the Waipiata Youth Centre.
