- 1. Title and commencement—(1) This notice may be cited as the Positive List of Controlled Goods and Services 1981, Amendment No. 16 and shall be read together with and deemed part of the Positive List of Controlled Goods and Services 1981* (hereinafter referred to as the principal notice).
 - (2) This notice shall come into force on the 10th day of March 1986.
- 2. First Schedule amended by omitting item No. 9—The First Schedule to the principal notice is hereby amended by omitting item No. 9 (an item relating to bananas).
- **3. First Schedule amended by omitting item No. 15**—The First Schedule to the principal notice (as amended by The Positive List of Controlled Goods and Services 1981, Amendment No. 6) is hereby amended by omitting item No. 15 (an item relating to neutral spirit).
- **4. First Schedule amended by omitting item No. 18**—The First Schedule to the principal notice is hereby amended by omitting item No. 18 (an item relating to imported oranges).
- **5. Revocation**—The Positive List of Controlled Goods and Services 1981, Amendment No. 6 is hereby revoked.
