ORDER IN COUNCIL

At Wellington this 28th day of February 1994

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to paragraphs (d) and (m) of section 40(1) of the Medical Auxiliaries Act 1966, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Podiatrists Regulations 1982, Amendment No. 8, and shall be read together with and deemed part of the Podiatrists Regulations 1982\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1994.

**2. Fees**—The principal regulations are hereby amended by revoking regulation 9 (as substituted by regulation 2 of the Podiatrists Regulations 1982, Amendment No. 7), and substituting the following regulation:

“9. (1) The fee for registration as a podiatrist shall be \$230.00.

“(2) The fee for a certificate of registration as a podiatrist shall be \$36.00.

“(3) The fee for an annual licence issued to a registered podiatrist shall be \$270.00.

“(4) The fee for an alteration in, or addition to, an entry in the register, other than a change of address or change of name on marriage or correction of an error for which the person registered is not responsible, shall be \$20.00.

“(5) The fee for the restoration of a name to the register under section 21 of the Act shall be \$70.00.

“(6) The fee for inspection of the register shall be \$36.00.

“(7) The fee for examination under regulation 4 (1) (b) of these regulations shall be \$1,000.00.

“(8) The fee for supplying any certificate for the purpose of enabling a podiatrist to seek registration outside New Zealand shall be \$47.00.”

**3. Fees inclusive of goods and services tax**—The fees fixed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

**4. Revocation**—The Podiatrists Regulations 1982, Amendment No. 7 are hereby consequentially revoked.

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 April 1994, prescribe a new scale of fees payable under the Podiatrists Regulations 1982. The fee for an annual licence issued to a registered podiatrist is increased.

The fees prescribed are inclusive of goods and services tax.
