THE RADIO AMENDMENT REGULATIONS 1943, NO. 2

At the Government House at Wellington, this 23rd day of June, 1943

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Post and Telegraph Act, 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Radio Amendment Regulations 1943, No. 2.
- 2. These regulations shall be read together with and form part of the Radio Regulations 1932* (hereinafter called the principal regulations).

3. These regulations shall come into force on the 1st day of July, 1943.

4. Regulation 73 of the principal regulations is amended by revoking clause (2) thereof as amended by the Radio License Fee Amendment Regulations 1935, and by revoking clause (3) thereof.

5. Regulation 6 of the Radio License Fee Amendment Regulations

1935 is consequentially revoked.

- 6. Regulation 210 of the principal regulations as amended by the Radio Amendment (Radio-dealers) Regulations 1935 and the Radio Amendment (Radio-dealers) Regulations 1942 is hereby revoked, and the following substituted:—
- "210. (1) Except as otherwise provided in these regulations, the fee for a radio-dealers' license shall be as follows, payable in advance:—
 - "(a) For a license of Class I: £5 per annum.
 - "(b) For a license of Class II: £2 10s. per annum.
 - "(c) For a license of Class III: £1 per annum.
 - "(d) For a license of Class IV: £5 per annum.
 - "(e) For a license of Class V: £1 Î0s. per annum. "(f) For a license of Class VI: £1 10s. per annum.
- "(2) The fee for a duplicate license shall be 5s. Such a license shall be issued only upon production of satisfactory evidence of the loss, mutilation, or destruction of the original license."

- 7. Regulation 9 of the Radio Amendment (Radio-dealers) Regulations 1935 and Regulation 10 of the Radio Amendment (Radio-dealers) Regulations 1942 are consequentially revoked.
- 8. Subject to appropriation by the General Assembly of funds for the purpose, there may, in respect of any radio-dealer's license current at the time of coming into force of these regulations, be repaid to the licensee in respect of the unexpired period thereof any sum in excess of the license fee that would have been payable if the fee had been apportionable and had for the period until the coming into force of these regulations been payable at the rate heretofore prescribed and thereafter at the rate prescribed by these regulations.
