



**THE ROTORUA AND TAUPO TROUT FISHING  
REGULATIONS 1980, AMENDMENT NO. 2**

ORDER IN COUNCIL

At the Government Buildings at Wellington this 14th day of June 1982

Present:

THE RIGHT HON. R. D. MULDOON PRESIDING IN COUNCIL

PURSUANT to the Fisheries Act 1908 and section 14 of the Maori Land Amendment and Maori Land Claims Adjustment Act 1926, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Rotorua and Taupo Trout Fishing Regulations 1980, Amendment No. 2, and shall be read together with and deemed part of the Rotorua and Taupo Trout Fishing Regulations 1980\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of July 1982.

(3) Regulation 8 of these regulations shall apply to all licences issued in respect of any period commencing on or after that day.

**2. Interpretation**—Regulation 2 (1) of the principal regulations is hereby amended by inserting, in the definition of the term “open season” in respect of the Rotorua Trout Fishing District after the words “Aratiatia Lake up to Huka Falls” in paragraph (a), the words “Lake Rotokura and Dry Lake (commonly known as the Karioi Lakes)”.

**3. Fishing without a licence prohibited**—Regulation 3 (2) of the principal regulations is hereby amended by revoking paragraph (p), and substituting the following paragraph:

“(p) The Tokaanu Tailrace for a distance of 110 m downstream from the powerhouse as indicated by a line drawn between the normal position of 2 landmarks situated opposite each other on the banks of the said Tailrace.”.

**4. Fishing in close season prohibited**—Regulation 13 of the principal regulations is hereby amended by adding, as subclause (2), the following subclause:

“(2) No person shall, during any close season for the Ohau Channel, take trout from those waters of Lake Rotorua which lead into the Ohau Channel and which are inwardly bounded by landmarks.”

**5. Restrictions on methods of fishing**—Regulation 17 (1) (d) of the principal regulations is hereby amended by omitting the words “nearest part of the hook”, and substituting the word “shank”.

**6. Restriction on use of boats in Taupo District**—Regulation 19 (2) of the principal regulations is hereby amended by omitting the words “at one end only”, and substituting the words “parallel to the river flow with not more than 2 anchors”.

**7. Taking, possession, or sale of indigenous fish**—Regulation 48 (1) of the principal regulations is hereby amended by inserting after the words “Special Act”, the words “and regulation 45 of these regulations”.

**8. Increase in licence fees**—(1) The principal regulations are hereby amended by revoking the Third Schedule (as substituted by regulation 5 of the Rotorua and Taupo Trout Fishing Regulations 1980, Amendment No. 1), and substituting the Third Schedule set out in the Schedule to these regulations.

(2) Regulation 5 of and the Schedule to the Rotorua and Taupo Trout Fishing Regulations 1980, Amendment No. 1, are hereby consequentially revoked.

**9. Restrictions on lures**—The Fourth Schedule to the principal regulations is hereby amended by adding to paragraph 2 (b) of Column 1 the words “where the mouth of the outlet is designated by landmarks”.

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations amend the Rotorua and Taupo Trout Fishing Regulations 1980.

*Regulation 2* extends the open season on Lake Rotokura and Dry Lake.

*Regulation 3* extends the prohibited fishing zone on the Tokaanu Tailrace below the powerhouse.

*Regulation 4* reintroduces the presence of landmarks at the Ohau Channel to indicate prohibited fishing waters during the close season of the Ohau Channel.

*Regulation 5* corrects the definition of maximum hook size.

*Regulation 6* permits the use of 2 anchors when fly fishing from a boat in the Taupo District if the boat is anchored parallel to the river flow.

*Regulation 7* clarifies the right to take indigenous fish for piscicultural, scientific, or other purposes.

*Regulation 8* prescribes an increase in licence fees. The whole-season fee increases from \$15 to \$18.

*Regulation 9* defines the outlet of Lake Rotoiti as being a place indicated by landmarks.
