

THE REPORTING CENTRES NOTICE 1984

PURSUANT to section 4A of the Criminal Justice Amendment Act 1962, the Minister of Justice hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Reporting Centres Notice 1984.
 - (2) This notice shall take effect from the 1st day of May 1984.
- 2. Constitution of reporting centres—(1) The land first described in the Schedule to this notice, and the land secondly described in the Schedule to this notice, are hereby declared to be reporting centres to be used with and for the purposes of the Toroa Street Work Centre*.

(2) The land thirdly described in the Schedule to this notice is hereby declared to be a reporting centre to be used with and for the purposes of

the Chambers Street Work Centre†.

(3) The land fourthly described in the Schedule to this notice is hereby declared to be a reporting centre to be used with and for the purposes of the Powderham Street Work Centre[†].

REPORTING CENTRES FOR TOROA STREET WORK CENTRE

First, all those parcels of land in the South Auckland Land District, containing 1667 square metres, more or less, situated in Block XIII Rangitaiki Upper Survey District, in the Parish of Matata, being Lots 145 and 146 on Deposited Plan S. 4716 and part Allotment 315, and being the whole of the land comprised and described in certificates of title, Volume 9c, folio 158, and Volume 9c, folio 159, South Auckland Registry.
