

THE REPORTING CENTRES NOTICE 1986

PURSUANT to subsections (2) and (4) of section 126 of the Criminal Justice Act 1985, the Minister of Justice hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Reporting Centres Notice 1986.
 - (2) This notice shall take effect from the 15th day of August 1986.
- 2. Constitution of reporting centres—(1) The land described in the First Schedule to this notice is hereby declared to be a reporting centre to be used with and for the purposes of the Brisbane Street Work Centre*.
- (2) The land described in the Second Schedule to this notice is hereby declared to be a reporting centre to be used with and for the purposes of the Myrtle Street Work Centre†.
- (3) The land described in the Third Schedule to this notice is hereby declared to be a reporting centre to be used with and for the purposes of the Hinemoa Street Work Centre‡.
- (4) The land described in the Fourth Schedule to this notice, and the land described in the Fifth Schedule to this notice, is each hereby declared to be a reporting centre to be used with and for the purposes of the Wood Street Work Centre*.
- (5) The building described in the Sixth Schedule to this notice is hereby declared to be a reporting centre to be used with and for the purposes of the Porchester Road Work Centre‡.
- (6) The land described in the Seventh Schedule to this notice is hereby declared to be a reporting centre to be used with and for the purposes of the Chambers Street Work Centres.
