

# THE REPORTING CENTRES NOTICE 1989

Pursuant to subsections (2) and (4) of section 126 of the Criminal Justice Act 1985, the Minister of Justice hereby gives the following notice.

#### NOTICE

1. Title and commencement—(1) This notice may be cited as the Reporting Centres Notice 1989.

(2) This notice shall take effect from the 15th day of June 1989.

2. Constitution of reporting centres—(1) The land described in the First Schedule to this notice is hereby declared to be a reporting centre to be used with and for the purposes of the Toroa Street Work Centre\*.

(2) The land described in the Second Schedule to this notice is hereby declared to be a reporting centre to be used with and for the purposes of

the Powderham Street Work Centre†.

- (3) The land described in the Third Schedule to this notice is hereby declared to be a reporting centre to be used with and for the purposes of the David Street Work Centre‡.
- 3. Revocations and amendment—(1) The Reporting Centre (Powderham Street Work Centre) Notice 1984§ is hereby revoked.

(2) The Reporting Centres Notice 1988 is hereby amended—

- (a) By omitting from clause 2 the words "and the parcel of land described in the Second Schedule to this notice,":
- (b) By revoking the Second Schedule.

# FIRST SCHEDULE

Cl. 2

All that parcel of land in the Gisborne Land District containing 367 square metres, more or less, situated in Section 2, Town of Opotiki, being Lot 2 on Deposited Plan 11388 (Auckland), and being the whole of the land comprised and described in certificate of title, Volume 2D, folio 530, Gisborne Registry.

## SECOND SCHEDULE

All that parcel of land in the Taranaki Land District containing 1619 square metres, more or less, situated in the Borough of Waitara, being Lot 1 on Deposited Plan 10976, being part Sections 5 and 6, Block LXXVIII, Town of Waitara West, being all the land comprised and described in certificate of title, Volume C4, folio 1130, Taranaki Registry.
