REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Real Estate Agents Regulations 1977, Amendment No. 2, and shall be read together with and deemed part of the Real Estate Agents Regulations 1977* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Increase in fees—The principal regulations are hereby amended by revoking the Second Schedule, and substituting the Second Schedule set out in the Schedule to these regulations.
