HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 122 of the Real Estate Agents Act 1976, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Real Estate Agents Regulations 1977, Amendment No. 4, and shall be read together with and deemed part of the Real Estate Agents Regulations 1977* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 10th day of January 1990.
- 2. New Second Schedule substituted—The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 2 of the Real Estate Agents Regulations 1977, Amendment No. 2), and substituting the Second Schedule set out in the Schedule to these regulations.

- **8. Fees exclusive of goods and services tax**—The fees fixed by these regulations are exclusive of goods and services tax under the Goods and Services Tax Act 1985.
- **4. Revocation**—The Real Estate Agents Regulations 1977, Amendment No. 3 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 10 January 1990, amend the Real Estate Agents Regulations 1977 by substituting a new scale of fees. Items 9 and 13 to 15 are new. The other fees are unchanged from the present scale.

These regulations are administered in the Department of Justice.
