**ORDER IN COUNCIL.**

At the Government Buildings at Wellington, this 15th day of  
March, 1939.

Present :

THE RIGHT HON. M. J. SAVAGE PRESIDING IN COUNCIL.

PURSUANT to the Reciprocal Enforcement of Judgments Act, 1934, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby order as follows :—

1. This Order may be cited as the Reciprocal Enforcement of Judgments Order 1939.

2. The Proclamations referred to in the Schedule hereto (being Proclamations issued under section 3 of the Administration of Justice Act, 1922, and in force on the passing of the Reciprocal Enforcement of Judgments Act, 1934, and continued in force by virtue of section 12 of the last-mentioned Act) are hereby varied in manner hereinafter appearing.

3. All Courts in any respective part of His Majesty's Dominions named in the first column of the said Schedule which exercise there exclusively or in part substantially the like jurisdiction as is exercised by the Supreme Court of Judicature in England, or as was heretofore exercised by the Supreme Courts of Law or Equity at Westminster or the High Court of Admiralty in England, shall for the purposes of Part I of the Reciprocal Enforcement of Judgments Act, 1934, and until further provision be made in the premises, be deemed superior Courts of that respective part of His Majesty's Dominions.
