THE RATIONING EMERGENCY REGULATIONS 1942 (REPRINT)

C. L. N. NEWALL, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington, this 24th day of April, 1942

Present:

THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL

Pursuant to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Rationing Emergency Regulations 1942.

(2) These regulations shall be read together with and deemed part

of the Supply Control Emergency Regulations 1939.*

2. (1) In these regulations, unless the context otherwise requires,—
"Area" or "rationing area" means a rationing area constituted
under these regulations:

"Available coupons", in relation to the supply of any rationed goods, means coupons for the time being available under

these regulations for the supply of those goods:

C"Butter" means the substance usually known as butter manufactured from cow's milk or from any product of cow's milk:

"Consumer", in relation to any goods, means a person who purchases or obtains those goods for any purpose other than

resale or use in the manufacture of goods for sale:

"Controller" means the Rationing Controller appointed under these regulations, and includes any person for the time being authorized to exercise or perform any of the Controller's powers or functions:

- "Coupon" means a coupon that forms or formed part of a ration document:
- ["Dairy" means—
 - (a) A milk-house, milk-shop, dairy factory, and any other place where dairy-produce is collected, deposited, treated, separated, prepared, or manufactured, or is sold or offered or exposed for sale; and includes

(b) A farm, stockyard, milking-yard, paddock, shed, stable, stall, and any other place where cows from which the milk-supply of a dairy is obtained are depastured or

kept:

"Dairy-produce" means milk, cream, butter, or cheese, and includes any other product of milk or cream:

- "Locality", in relation to any business, means a rationing area, or a separate part of any rationing area, in which the business is carried on:
- ["Manufacturing dairy" means any premises registered as a manufacturing dairy under the Dairy-produce Regulations 1938*:
 - "Occupier", in relation to a supplying dairy, includes every person having for the time being the management or control thereof:
 - "Owner" means the owner, whether jointly or severally, and includes the owner's agent or manager; it includes also, in the case of a company, the manager, secretary, or other principal officer thereof:

"Permit" means a permit granted by the Controller under these regulations:

["Producer of milk or cream" means any person engaged in the production of milk or cream, whether as the owner or occupier of any dairy or as an employee or share-milker or otherwise; and the production of milk or cream, whether for sale or otherwise, shall be deemed to be a business carried on by the producer thereof:

"Ration document" means a ration book, ration card, or other ration document issued by the Controller for the purposes

of these regulations:

"Rationed goods" means goods for the time being declared

under these regulations to be rationed goods:

"Rationing Officer", in relation to any area, means the Rationing Officer for the time being in office for that area under these regulations, and includes any person for the time being authorized to exercise or perform any of the Rationing Officer's powers or functions:

"Shop" includes any place in or from which the business of

supplying goods to consumers is carried on:

["Supplying dairy" means any dairy used in connection with the supply of milk or cream to a manufacturing dairy:]

"Trader", in relation to any goods, means a person carrying on in New Zealand the business of supplying those goods, whether or not he carries out any process in the manufacture of them, [and, in relation to any meat produced by the slaughter of any stock for human consumption, includes the person owning the stock at the time of its slaughter].

- (2) If any question arises as to the locality or localities in which any business is being carried on in any area, it shall be determined by the Director-General of the Post and Telegraph Department, and his decision shall be final.
 - (3) For the purposes of these regulations—
 - (a) Where any trader carries on business in or from two or more shops, the business carried on in or from each of those shops shall be deemed to be a separate business:
 - (b) Where any trader carries on business in two or more localities in which he has no shops, the business carried on in each of those localities shall be deemed to be a separate business:
 - (c) Where any trader carries on business in or from any shop and in any locality in which he has no shop, the business carried on in or from that shop and the business carried on in that locality shall be deemed to be separate businesses:
 - (d) Where any person sells any goods by sale by auction within the meaning of the Auctioneers Act, 1928,* whether or not he is the holder of an auctioneer's license under that Act, and whether or not the sale is made in the course of any business carried on by him, he shall be deemed to be a trader in those goods within the meaning of these regulations, and shall be deemed to supply the goods to the purchaser as a trader therein.

The definitions printed within brackets in subclause (1) were inserted by Regulation 2 of the Rationing Emergency Regulations 1942, Amendment No. 2 (Serial number 1943/165). The words printed within brackets in the definition of the term "ration document" were substituted for the words "emergency ration card, or leave ration card" by Regulation 7 (2) of the Rationing Emergency Regulations 1942, Amendment No. 3 (Serial number 1944/119). The words printed within brackets in the definition of the term "trader" were added by Regulation 3 of the same regulations. Paragraph (d) was added to subclause (3) by Regulation 2 of the Rationing Emergency Regulations 1942, Amendment No. 1 (Serial number 1943/35).

RATIONING CONTROLLER

3. (1) The Minister may from time to time appoint a Controller, to be known as the Rationing Controller.

(2) The Controller shall hold office during the pleasure of the

Minister.

(3) The Controller shall be subject in all things to the control of the Minister, and shall act in accordance with all directions, general or special, given to him by the Minister.

4. (1) The general functions of the Controller shall be to administer these regulations and to regulate, control, or prohibit the supply, acquisition, distribution, or use of rationed goods so far as may be necessary for the purposes of these regulations.

(2) The Controller shall have all such powers and rights and may do such things and give such general or special directions as may appear to him to be necessary to enable him to carry out his functions.

RATIONING OFFICERS

5. The Chief Postmaster of each postal district recognized as such by the Post and Telegraph Department shall be a District Rationing Officer for the purposes of these regulations.

6. The Director-General of the Post and Telegraph Department may from time to time divide each postal district into areas, to be known as rationing areas. For each area there shall be a Rationing Officer, who shall be appointed by the Director-General, and shall hold office during his pleasure.

7. (1) Every District Rationing Officer in respect of his district and every Rationing Officer in respect of his area shall have such powers, functions, and duties as may from time to time be conferred or imposed upon him by these regulations or delegated to him under the Supply Control Emergency Regulations 1939.

(2) In the exercise of any powers or functions under or for the purposes of these regulations, every District Rationing Officer and every Rationing Officer shall act in accordance with all directions, general or special, given in that behalf by the Controller or by the

Director-General of the Post and Telegraph Department.

(3) Every delegation or direction made or given to any District Rationing Officer or to any Rationing Officer by the Controller shall be made or given through the Director-General of the Post and Telegraph Department.

RATIONED GOODS

8. (1) The Minister may from time to time, by Order, declare any goods to be rationed goods for the purposes of these regulations.

(2) By any such Order or by a subsequent Order the Minister may—

(a) Require retailers of the rationed goods to be licensed under these regulations:

(b) Require consumers of the rationed goods to be registered under

these regulations.

- (3) Any Order under this regulation may be from time to time amended or at any time revoked by the Minister by a subsequent Order.
- (4) Every Order under this regulation shall come into force on a date to be specified in that behalf in the Order. Different dates may be so specified in respect of the Chatham Islands and the rest of New Zealand.

The goods referred to below have been declared to be rationed goods at the date of this reprint.

Butter.—See the Butter Rationing Order 1943 (Serial number 1943/166), which requires retailers to be licensed, and consumers to be registered.

Clothing.—See the Clothing Rationing Order 1942 (Serial number 1942/162), and also the Clothing Rationing Order 1943 (Serial number 1943/80), which requires retailers to be licensed.

Eggs.—See the Egg Rationing Order 1943 (Serial number 1943/87), which requires retailers to be licensed, and consumers to be registered. See

also the Egg Rationing Permit 1944 (Serial number 1944/49).

Meat.—See the Meat Rationing Order 1944 (Serial number 1944/30), which requires retailers to be licensed. See also the Meat Rationing Permit (No. 2) 1944 (Serial number 1944/73) as to coupon-free meat.

Sugar.—See the Sugar Rationing Order 1942 (Serial number 1942/117), which requires retailers to be licensed, and consumers to be registered.

 $\it Tea.$ —See the Tea Rationing Order 1942 (Serial number 1942/242), which requires retailers to be licensed.

SUPPLY OF RATIONED GOODS

Supply to Consumers

9. (1) The provisions of this regulation shall apply to the supply of rationed goods by a trader in those goods to a consumer.

(2) No trader shall supply any rationed goods to a consumer otherwise than in accordance with these regulations, and either—

(a) Against the surrender or cancellation of the appropriate number of available coupons; or

(b) Under the authority of a permit granted by the Controller under these regulations.

(3) Where the retailers of any rationed goods are required to be licensed under these regulations, no trader shall supply any of those goods to a consumer otherwise than in the course of a business in respect of which the trader is for the time being licensed under these

regulations as a retailer of those goods.

(4) Where the consumers of any rationed goods are required to be registered under these regulations, no trader shall supply any of those goods to any consumer against the surrender or cancellation of coupons of a kind comprised in a ration book unless the consumer is for the time being duly registered with the trader under these regulations in respect of those goods and in respect of the business in the course of which the goods are supplied.

(5) Except where the goods are ordered by post, a trader shall not supply rationed goods against the surrender or cancellation of coupons of a kind comprised in any ration document unless the ration document has been produced to him and he has in accordance with the directions of the Controller either detached therefrom or cancelled therein the

appropriate number of available coupons.

(6) A trader shall not supply rationed goods by post against the surrender or cancellation of coupons unless he has received from the consumer the appropriate number of available coupons bearing on the back the name and address of the consumer and the number of his ration document, and, if the directions of the Controller so require, has cancelled those coupons in accordance with the directions of the Controller.

Supply to Persons other than Consumers

[10. (1) The provisions of this regulation shall apply to the supply of rationed goods by any person to any other person who is not a consumer whether or not the person supplying the goods or the person to whom they are supplied is a trader in those goods.

(2) No person shall supply any rationed goods otherwise than in accordance with these regulations and under the authority of a permit

granted by the Controller under these regulations.

Regulation 10 was substituted by Regulation 3 of the Rationing Emergency Regulations 1942, Amendment No. 1 (Serial number 1943/35).

Acquisition of Rationed Goods

[11. No person shall acquire any rationed goods from any other person in circumstances in which that other person is prohibited from supplying the goods to him.]

Regulation 11 was substituted by Regulation 2 of the Rationing Emergency Regulations 1942, Amendment No. 3 (Serial number 1944/119).

Directions

12. Notwithstanding anything in these regulations, the Controller may give directions regulating or prohibiting the supply or acquisition of rationed goods by any person or a person of any class or description specified in the directions.

Licensing of Retailers

- 13. (1) The Rationing Officer for any area may from time to time issue to any trader a license or two or more licenses as a retailer of any rationed goods specified in the license.
- (2) Every such license shall be issued in respect of the business carried on by the licensee in or from one shop or in one locality situated in the area and specified in the license.

Rationing Emergency Regulations 1942 (Reprint)

(3) Any such license may be at any time revoked by the Rationing Officer.

(4) Every such license shall be deemed to be revoked if the licensee specified in the license ceases to carry on business in or from the shop or in the locality specified in the license, or dies, or (being a corporation) is dissolved.

(5) Where any such license is revoked or deemed to be revoked it shall be the duty of the licensee and of any other person having possession of the license to cause the license to be forthwith delivered

to the Rationing Officer.

As to the cases in which retailers are required to be licensed at the date of this reprint, see the note to Regulation 8.

Registration of Consumers

14. (1) Upon application being duly made by or on behalf of any consumer to any trader who is for the time being carrying on any business as a retailer of any rationed goods the retailer may register the consumer in respect of those goods and in respect of that business.

(2) No person shall apply for registration as a consumer of any goods in respect of any business of any trader at any time while he is registered as a consumer of those goods in respect of any other business, whether carried on by the same trader or by any other trader.

(3) No person shall apply for registration as a consumer of any goods otherwise than in accordance with these regulations and with

any directions of the Controller.

(4) No trader shall register any person as a consumer of any goods otherwise than in accordance with these regulations and with any directions of the Controller, or otherwise than upon an application duly made under these regulations.

(5) No trader shall register any person as a consumer of any goods at any time before the Controller has given public notice authorizing the registration of consumers of those goods and specifying the class of coupons and counterfoils that will be available for the supply of those goods.

(6) No trader shall detach any counterfoil of any class from any ration document or accept any counterfoil of any class from any person at any time before the Controller has given public notice specifying the goods to which counterfoils of that class will relate and authorizing the registration of consumers of those goods.

(7) No trader shall cause or permit his name or address to be written on any ration document as the name or address of a retailer—

(a) In respect of any class of coupons or counterfoils, at any time before the Controller has given public notice specifying the goods to which counterfoils of that class will relate and authorizing the registration of consumers of those goods:

(b) In respect of any goods, at any time before the Controller has given public notice authorizing the registration of consumers of those goods and specifying the class of coupons and counterfoils that will be available for the supply of those

Miscellaneous Provisions as to Supply

15. (1) Where any trader who holds any rationed goods for the purposes of his business uses or appropriates the goods for or to any purpose other than the purposes of any business carried on by him he shall for the purposes of these regulations be deemed to supply the goods to another person who is a consumer.

(2) Where any trader who holds any rationed goods for the purposes of any business carried on by him transfers the goods to any other business carried on by him, or uses or appropriates them for or to the purposes of any other business carried on by him, or, where the goods are held for a particular purpose, uses or appropriates them for or to any other purpose of any business carried on by him, he shall be deemed for the purposes of these regulations to supply the goods to another person who is not a consumer.

[(3) For the purposes of this regulation every person owning any stock at the time of its slaughter shall be deemed to be carrying on the business of slaughtering stock, and that business shall be deemed to be a separate business from any other business carried on by him.

(4) Any farmer may, without the surrender or cancellation of any coupons, supply for consumption in his own household any meat

produced by the slaughter of stock owned by him:

Provided that nothing in this subclause shall excuse any person from compliance with any directions of the Rationing Controller under these regulations, or from compliance with any restrictions or obligations imposed by or under any Act, or by or under any other regulations.

Subclauses (3) and (4) were added by Regulation 4 of the Rationing Emergency Regulations 1942, Amendment No. 3 (Serial number 1944/119). As to the necessity to deposit ordinary meat coupons with a Rationing Officer where a farmer kills his own meat, see the Meat Rationing Notice 1944 (Gazette, 25th August, 1944, Vol. II, page 1047).

[15a. For the purposes of these regulations all meat that is delivered from any slaughterhouse or other slaughtering-place to any person shall be deemed to be supplied by the owner of the slaughterhouse or other slaughtering-place to that person, and to be acquired by that person accordingly, notwithstanding that that person may be the owner of the meat or may have been the owner of the stock from which the meat is derived.

Regulation 15A was inserted by Regulation 5 of the Rationing Emergency Regulations 1942, Amendment No. 3 (Serial number 1944/119).

- 16. Where goods are invoiced by a trader to another trader who in relation to the supply of those goods is the agent either of the supplier or of the person to whom or to whose order they are to be supplied, the supplier shall be deemed to supply those goods to the agent, and when the goods are supplied to or to the order of the person to be supplied the agent shall be deemed to supply them.
- 17. A person disposing by way of liquidation of the assets of any business which comprised the supply of rationed goods shall be deemed to be carrying on that business.

■Special Provisions relating to Butter

17A. This regulation and Regulations 17B, 17c, and 17D hereof shall apply whenever butter and margarine are rationed goods within the meaning of these regulations.

- 17B. (1) Except under the authority of a permit granted by the Controller, no person shall manufacture any butter elsewhere than in a manufacturing dairy unless he is a producer of milk or cream.
- (2) Except under the authority of a permit granted by the Controller, no producer of milk or cream who is the occupier of a dairy that is for the time being or has at any time during the previous twelve months been a supplying dairy shall—
 - (a) Cause or permit any butter to be manufactured in that dairy, whether for sale or otherwise:
 - (b) Cause or permit any butter to be manufactured, whether for sale or otherwise, in any place other than that dairy or a manufacturing dairy from any milk or cream produced in that dairy:

Provided that this subclause shall not be deemed to prohibit the manufacture of any butter that the producer is for the time being authorized to supply by a permit granted by the Controller under these regulations or as a retailer licensed under these regulations.

(3) Except under the authority of a permit granted by the Controller, no producer of milk or cream who manufactures butter on any property shall cause or permit any butter manufactured or purchased by him to be supplied to any person other than a trader in butter:

Provided that this subclause shall not apply with respect to any butter that the producer is for the time being authorized to supply—

- (a) As a retailer licensed under these regulations; or
- (b) In accordance with subclause (4) of this regulation, for consumption on that property by himself or any other person.
- (4) No person who is a manufacturer of butter or a trader in butter (whether or not he is a licensed retailer) shall cause or permit any butter manufactured or purchased by him to be supplied or used for consumption by himself or any other person except either—
 - (a) Against the surrender or cancellation of the appropriate number of available coupons; or
 - (b) Under the authority of a permit granted by the Controller.
- **[17c.** Except under the authority of a permit granted by the Controller, no person shall use or consume or supply to any other person who is not a trader in cream—
 - (a) Any cream; or
 - (b) Any milk to which any cream has been added:

Provided that this regulation shall not be deemed to prohibit—

- (a) The use of cream for the manufacture of butter:
- (b) The supply of cream by any person to a manufacturing dairy:
- (c) The use or consumption in any household of cream obtained from milk held in the household for ordinary domestic consumption therein:
- (d) The use or consumption of any cream by any person for a purpose for which the supply of the cream to that person has been authorized by the Controller.
- 17D. (1) Except under the authority of a permit granted by the Controller, no owner of a manufacturing dairy shall in any season ending on the 31st day of July in any year supply to any other person or persons any cheese manufactured in that dairy in excess of the total quantity of such cheese supplied in the season ended on the 31st day of July, 1943.

(2) In the application of this regulation to the season ending on the 31st day of July, 1944, all cheese supplied in that season before the commencement of this regulation shall be taken into account.

Regulations 17a-17b and the heading thereto were inserted by Regulation 3 of the Rationing Emergency Regulations 1942, Amendment No. 2 (Serial number 1943/165), but Regulation 17c was substituted by Regulation 6 of the Rationing Emergency Regulations 1942, Amendment No. 3 (Serial number 1944/119).

The date of the commencement of Regulation 17D was 27th October,

1943.

RATION DOCUMENTS, COUPONS, AND PERMITS

18. (1) Such ration books, Tration cards, and other ration documents as are deemed necessary for the purposes of these regulations may be issued in accordance with the directions of the Controller to such persons or classes of persons, in such circumstances, and upon or subject to such conditions as the Controller from time to time directs.

[(2) A fee of 2s. 6d. shall be payable for the issue of a ration book to replace any ration book that has been lost, destroyed, or defaced: Provided that the Controller may in any case remit that fee

wholly or partly on the ground of hardship.

- (3) Where a new ration book is issued to any person to replace a lost ration book, and that person subsequently finds the lost ration book or has it in his possession he shall forthwith return it to a Rationing Officer.
- (4) Where upon applying for the issue of a ration document any person (hereinafter referred to as the employee) is required to produce to the issuing officer the registration fee coupon-book issued to him under the Social Security Act, 1938, and that coupon-book is deposited with his employer, the employer shall forthwith deliver the coupon-book to the employee to enable him to produce it to the issuing officer with his application for a ration document, and the employee shall within seven days after receiving the coupon-book return it to the employer.

The words printed within brackets in subclause (1) were substituted for the words "emergency ration cards, and leave ration cards" by Regulation 7 (1) of the Rationing Emergency Regulations 1942, Amendment No. 3 (Serial number 1944/119).

Subclause (2) was substituted by Regulation 4 of the Rationing Emergency Regulations 1942, Amendment No. 1 (Serial number 1943/35).

- 19. (1) Every ration document issued under these regulations shall contain such coupons as the Controller from time to time directs.
- (2) Each coupon shall be available for the supply of such quantity of such rationed goods during such period or periods as the Controller from time to time directs.
- (3) For the purposes of these regulations the appropriate number of coupons in relation to the supply of any rationed goods shall be the number calculated in accordance with the directions of the Controller under this regulation, so, however, that where the number so calculated includes any fraction that fraction shall be treated as one.

As to the availability of coupons at the date of this reprint, see the Foodstuffs Rationing Coupon Notice 1944 (Gazette, 20th April, 1944, Vol. I, page 385), the Clothing Rationing Coupon Notice 1944 (Gazette, 8th June, 1944, Vol. II, page 698), and the Clothing Rationing Coupon Notice 1944, Amendment No. I (Gazette, 7th September, 1944, Vol. III, page 1107).

20. No consumer shall deposit any ration document or coupon with any trader except by surrendering the appropriate number of available coupons upon ordering or acquiring rationed goods, and no trader shall accept any deposit in contravention of this clause.

21. (1) Notwithstanding anything in these regulations, any person in possession of any ration document, coupon, permit, license, or other document shall if so directed by a general or special direction given by the Controller, deliver it to any person in any manner and at any

time specified in the direction.

(2) Where any person is in possession of a ration document, coupon, permit, license, or other document, and such possession is not authorized by or under these regulations, then, unless within seven days after the document has come into his possession he has returned it to the person entitled to the custody thereof or otherwise dealt therewith as provided by or under these regulations, he shall forthwith deliver the document to a Rationing Officer or to such other person as may be specified in that behalf in any instructions contained in the document.

(3) Any person authorized in writing by the Controller may, on production of his authority, require any person in possession of any ration document, coupon, permit, license, or other document to produce it to him, and may seize any such document which he believes on reasonable grounds to be evidence of the commission of an offence.

22. (1) No person shall for the purpose of obtaining rationed goods make use of any ration document, coupon, permit, license, or other document that has not been duly issued to him or to a person

for whose benefit the goods are being obtained.

(2) No trader shall supply any rationed goods against the surrender or cancellation of any coupon or under the authority of any permit if he has reason to believe that it is being used in contravention of this regulation.

23. Every trader who receives any coupons or permits upon the supply of rationed goods shall dispose of the coupons or permits in accordance with the general or special directions of the Controller.

24. No person shall, with intent to obtain goods in contravention of these regulations, or to enable any other person to do so, have in his possession any ration document, coupon, or permit that has been cancelled, or has been issued or surrendered in accordance with these regulations to any other person, or has been issued in contravention of these regulations or of any directions of the Controller, or by mistake, or as a result of any deceit, or as a result of any false or misleading statement or any material omission in any communication with or application to any person (whether in writing or otherwise).

Information and Returns

- 25. (1) This regulation shall apply to-
- (a) All traders in rationed goods:

(b) All persons carrying on businesses in the course of which rationed goods are [used or consumed]:

(c) All persons carrying on or managing establishments or institutions for the purposes of which rationed goods are **[used** or consumed]:

[(d) All producers of milk or cream.]

(2) Any person to whom this regulation applies shall, if so directed by a general or special direction given by the Controller, keep such books, accounts, and records relating to his business, establishment, or institution as may be specified in the direction, and furnish to the Controller or to such other person as may be specified in the direction such returns and information relating to his business, establishment, or institution as may be so specified.

- (3) Any person to whom this regulation applies, and any person employed in connection with the business, establishment, or institution carried on or managed by such a person shall, if requested so to do by the Controller,—
 - (a) Produce to any person mentioned in the request all books, accounts, records, licenses, and other documents relating to that business, establishment, or institution; and
 - (b) Permit any person authorized in that behalf by the Controller to enter and inspect such premises used for or in connection with the business, establishment, or institution as that person may require with a view to securing compliance with these regulations

[25a. The Controller may from time to time require any person to furnish, in a form to be approved by or acceptable to the Controller, any information or particulars that may be required for the purposes of these regulations.

Provisions for Enforcement of Regulations

- 25B. (1) For the purposes of this regulation the expression "rationed goods" shall be deemed to include cream.
 - (2) This regulation shall apply to-
 - (a) All traders in rationed goods:
 - (b) All persons carrying on businesses in the course of which rationed goods are used or consumed:
 - (c) All persons carrying on or managing establishments or institutions for the purposes of which rationed goods are used or consumed.
- (3) Where the Controller or any person acting with the authority of the Controller has reason to suspect that any person to whom this regulation applies has in or on any place or conveyance or in any package or receptacle any rationed goods which have been acquired by him in contravention of these regulations, or which are intended for supply to any other person in contravention of these regulations, the Controller or authorized person may search and detain for the purpose of search that conveyance, package, or receptacle or may enter upon and search that place or any part thereof and may take possession of any such rationed goods found upon such search:

Provided that no premises shall be searched under this regulation unless they are used for or in connection with the business, establishment, or institution of a person to whom this regulation applies.

- (4) Any rationed goods seized under this regulation shall be disposed of in such manner as the Controller directs.
- (5) If, after any rationed goods have been seized under this regulation, any person proves that he was entitled to the goods at the time of their seizure and that he had not acquired them in contravention of these regulations, and that they were not intended for supply to any other person in contravention of these regulations, he shall be entitled to the return of the goods or, if they have been

disposed of, he shall be entitled to payment for the goods under Regulation 9 of the Supply Control Emergency Regulations 1939* as if he had supplied the goods to the Crown at the time of their seizure.

Regulations 25A and 25B and the heading preceding Regulation 25B were inserted by Regulation 9 of the Rationing Emergency Regulations 1942, Amendment No. 3 (Serial number 1944/119).

OFFENCES

- 26. (1) Every person commits an offence against these regulations who—
 - (a) Without lawful excuse acts in contravention of or fails to comply in any respect with any provision of these regulations or any direction, restriction, requirement, or condition given or imposed under these regulations:
 - (b) With intent to deceive, makes any false or misleading statement or any material omission in any communication with or application to any person (whether in writing or otherwise) for the purposes of these regulations or for any other purpose relating to the supply or acquisition of rationed goods:

(c) Resists, obstructs, or deceives any person who is exercising or attempting to exercise any power or function under these

regulations:

- [(d) Makes any untrue or misleading statement or any material omission in any return or certificate or in any information or particulars (whether in writing or otherwise) furnished under or for the purposes of these regulations.
- (2) Every person who aids, abets, counsels, or procures or is in any way knowingly concerned with the commission of an offence against these regulations shall be deemed to have committed an offence against these regulations.
- (3) Any offence against these regulations committed by a servant or agent in the course of his employment shall be deemed to have been also committed by his employer or principal.

Paragraph (d) and subclauses (2) and (3) were added by Regulations 10 and 11 of the Rationing Emergency Regulations 1942, Amendment No. 3 (Serial number 1944/119).

27. Every person who commits an offence against these regulations shall be liable on summary conviction to imprisonment for a term not exceeding three months, or to a fine not exceeding £100 and (if the offence is a continuing one) to a further fine not exceeding £10 for every day during which the offence continues.
