THE REGISTRATION FOR EMPLOYMENT ORDER NO. 6

PURSUANT to Regulation 9C of the National Service Emergency Regulations 1940,* the Minister of Industrial Man-power doth hereby order and direct as follows:—

1. This Order may be cited as the Registration for Employment Order No. 6.

2. Subject to the exemptions hereinafter specified, every male person who at the date of this Order is a member of the General Reserve constituted by Regulation 5 of the National Service Emergency Regulations 1940† and has attained the age of fifty-one years but has not attained the age of sixty years shall within seven days after the date of this Order register for employment by completing a form provided for the purpose and delivering it to a District Man-power Officer either personally or by registered post.

3. Subject to the exemptions hereinafter specified, every male person who at any time after the date of this Order becomes a member of the General Reserve and at that time has attained the age of fifty-one years but has not attained the age of sixty years shall within seven days thereafter register for employment in the manner prescribed in clause 2 hereof.

4. Every male person who for the time being belongs to any one or more of the classes specified in the Schedule hereto shall be exempt from compliance with clause 2 or clause 3 of this Order.

5. If at any time after the date of this Order any male person ceases to be exempted under the last preceding clause from compliance with clause 2 or clause 3 of this Order, he shall within seven days thereafter register for employment in the manner prescribed in clause 2 hereof.

SCHEDULE.

EXEMPTIONS.

PERSONS registered or deemed to be registered for the purposes of Regulation 9C of the National Service Emergency Regulations 1940.

Persons rendering continuous service as members of any of His Majesty's naval, military, or air forces.

Persons employed as civilians by the Royal New Zealand Navy, the Army Department, or the Royal New Zealand Air Force.

Members of the Police Force.

Firemen who are in the full-time employment of Fire Boards or fire brigades.

Working owners and managers of farms who are fully employed on farms.
Persons employed in coal-mines, gold-mines, or scheelite-mines or engaged in petroleum-mining or prospecting for petroleum.
Employees of the New Zealand Government Railways Department.
Persons employed in the production or supply of gas or electricity or in the construction or maintenance of plant used for the production or supply of gas or electricity.
Persons serving in merchant ships.
Medical practitioners actively engaged in practice.
Practising dentists, and persons employed as dental mechanics.
Full-time employees of registered hospitals.
Practising pharmacists, and persons employed as dispensers.
Practising opticians, and persons employed as optical mechanics.
Judges of the Supreme Court, the Court of Arbitration, the Compensation Court, or the Native Land Court.
Stipendiary Magistrates.
Members of the General Assembly.
Officiating Ministers under the Marriage Act, 1908.
Persons who are outside New Zealand.
Persons in receipt of invalids' benefits under the Social Security Act, 1938.
Persons in receipt of war pensions for disablement assessed at not less than 75 per cent. which has arisen from service in any of His Majesty's naval, military, or air forces.
Inmates of any hospital or of the New Zealand Institute for the Blind.
Persons in respect of whom reception-orders are in force under the Mental Defectives Act, 1911 (whether or not they are detained in institutions under that Act), or who are detained as voluntary boarders under that Act.
Persons undergoing sentences of imprisonment or detained in Borstal institutions.
