REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Resource Management (Transitional, Fees, Rents, and Royalties) Regulations 1991, Amendment No. 4, and shall be read together with and deemed part of the Resource Management (Transitional, Fees, Rents, and Royalties) Regulations 1991\* (hereinafter referred to as the principal regulations).

(2) Except as provided in regulation 6 (2) of these regulations, these regulations shall come into force on the 30th day of September 1994.

**2. Payment of rents and royalties for existing licences, leases, permits, etc.**—(1) Regulation 7 (1) of the principal regulations (as amended by regulation 2 of the Resource Management (Transitional, Fees, Rents, and Royalties) Regulations 1991, Amendment No. 2) is hereby amended by omitting the expression “September 1994”, and substituting the expression “September 1996”.

(2) Regulation 7 (2) of the principal regulations (as amended by regulation 2 of the Resource Management (Transitional, Fees, Rents, and Royalties) Regulations 1991, Amendment No. 2) is hereby amended by omitting the expression “30th day of September 1994”, and substituting the expression “30th day of September 1996”.

(3) Regulation 2 of the Resource Management (Transitional, Fees, Rents, and Royalties) Regulations 1991, Amendment No. 2 is hereby consequentially revoked.

**3. Remission of rentals for existing licences**—Regulation 13 (3) of the principal regulations is hereby amended by omitting the expression “30th day of September 1994”, and substituting the expression “30th day of September 1996”.

**4. Geothermal royalties**—Regulation 14 (1) of the principal regulations is hereby amended by omitting the expression “30th day of September 1994”, and substituting the expression “30th day of September 1996”.

**5. Expiry**—(1) Regulation 20 of the principal regulations is hereby amended by omitting the expression “September 1994”, and substituting the expression “September 1996”.

(2) Regulation 4 of the Resource Management (Transitional, Fees, Rents, and Royalties) Regulations 1991, Amendment No. 2 is hereby consequentially amended by omitting the expression “September 1994”, and substituting the expression “September 1996”.

**6. Fees**—(1) The First Schedule to the principal regulations is hereby amended by omitting from the 3rd column of the item relating to an application for a water conservation order the expression “\$250”, and substituting the expression “\$1,000”.

(2) This regulation shall come into force on the 6th day of October 1994.

**7. Revocation**—The Resource Management (Transitional, Fees, Rents, and Royalties) Regulations 1991, Amendment No. 3 are hereby revoked.

**8. Expiry**—These regulations shall expire with the close of the 30th day of September 1996.

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 30 September 1994 and expire with the close of 30 September 1996, extend the period provided for the payment of certain rents and royalties for existing licences, leases, and permits in the coastal marine area, and in respect of geothermal rentals and royalties, at the existing rate until the close of 30 September 1996.

The fee for an application for a water conservation order is increased, on 6 October 1994, from \$250 to \$1,000.
