**THE ROYAL NEW ZEALAND AIR FORCE REGULATIONS 1938,
AMENDMENT NO. 3.**

GALWAY, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this 11th day of
October, 1939.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the powers and authorities conferred upon him by the Air Force Act, 1937, and of all other powers and authorities enabling him, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Royal New Zealand Air Force Regulations 1938, Amendment No. 3.

2. These regulations shall be read together with and form part of the Royal New Zealand Air Force Regulations 1938* (hereinafter called the principal regulations).

3. Regulation 152 of the principal regulations is amended by adding the following words to the end of paragraph (c) of clause (1) :
“ increased to 1s. per day after satisfactory service for one year in the rank of aircraftman, 1st class ”.

4. Regulation 155 of the principal regulations is amended by the addition of the following clause :—

“(2) An officer of the Air Force Reserve on transfer to the Regular Air Force or an officer on the Retired List on transfer to the Active List who has not within the period of five years immediately preceding such transfer received any free issue of uniform material or been paid any uniform outfit grant or uniform upkeep allowance may be granted a free issue of uniform cloth, buttons, braid, badges, and shoes in accordance with the appropriate scale for these articles set out in (a) and (c) of the preceding regulation, and shall be deemed for the purposes of Regulation 156 to have received a first appointment to a commission on the date of such transfer.”

5. Regulation 156 of the principal regulations is amended by the addition of the following clauses :—

“(3) No payment of the grant provided under clause (1) nor payment of any part thereof shall, except with the approval of the Air Board, be made to any officer who within the period of six months immediately preceding the date of his appointment to a commission in or of his transfer to the Regular Air Force has held a commission in any of His Majesty’s Air Forces.

“(4) Notwithstanding the provisions of clause (1) of this regulation, an officer of the Air Force Reserve on transfer to the Regular Air Force, or any officer on the Retired List on transfer to the Active List, who has not been paid any uniform outfit grant within five years or any uniform upkeep allowance within three years immediately preceding such transfer may be paid a uniform outfit grant of £20.”

6. Regulation 158 of the principal regulations (as replaced by Regulation 3 of the Royal New Zealand Air Force Regulations 1938, Amendment No. 2) is amended by the addition of the following clause :—

“(2) For the purpose of this regulation an officer to whom no uniform outfit grant is payable under Regulation 156 shall be deemed to have completed one year of service on the 31st day of March following the date of his appointment to a commission in or transfer to the Regular Air Force and, notwithstanding clause (1) hereof, such an officer shall be paid in advance a uniform outfit allowance at the prescribed rate for the period from the date of such appointment or transfer to the 31st day of March following.”

7. Regulation 159 of the principal regulations is amended by inserting, after the item “Caps, S.D., W.O. pattern . . . 1” in paragraph (e) of clause (1), the items :—

“Badges, cap, S.D., W.O. pattern	1
“Badges, cap, F.S., Officer’s pattern	1”

and by the addition, after clause (2) thereof, of the following additional clause :—

“(3) In each year one free issue of the following items of clothing may be made to drivers, petrol, upon return to store for disposal of such clothing worn out through fair wear-and-tear :—

“Cap, S.D.	1
“Coat, great	1
“Jacket, S.D., blue	1
“Trousers, S.D., blue	1 pair.”

8. Regulation 161 of the principal regulations (as replaced by Regulation 3 of the Royal New Zealand Air Force Regulations 1938, Amendment No. 2) is amended by the addition of the following clause :—

“(2) In time of war no further payment of uniform upkeep allowance under this regulation shall be made, and airmen’s clothing worn out by fair wear-and-tear shall be replaced subject to such scale and on such conditions as may from time to time be approved by the Air Board.”

9. Regulation 194 of the principal regulations is amended by revoking the words “payable by household consumers to the supply authorities in the districts wherein the quarters are situated”, and substituting the following words : “laid down from time to time by the Air Board.”

10. Regulation 233 of the principal regulations (added by Regulation 4 of the Royal New Zealand Air Force Regulations 1938, Amendment No. 2) is amended by revoking clause (3), and substituting the following clause :—

“(3) On being called up for continuous service in time of war an officer may be paid a further uniform outfit grant of £20 and shall be required to furnish himself with the uniform and kit as set out in Regulation 154 (a) and (c).”

11. Regulation 235 of the principal regulations (added by Regulation 4 of the Royal New Zealand Air Force Regulations 1938, Amendment No. 2) is amended by the addition of the following clause :—

“(3) On being called up for continuous service in time of war clothing of airmen shall when worn out by fair wear-and-tear be replaced subject to the same scale and to the same conditions as may from time to time be approved by the Air Board for the replacement in time of war of clothing of airmen of the Regular Air Force under clause 2 of Regulation 161.”
