HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Marine Farming Act 1971, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Rock Oyster Farming Regulations 1964, Amendment No. 2, and shall be read together with and deemed part of the Rock Oyster Farming Regulations 1964* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Metric amendments—(1) The principal regulations are hereby amended in the manner indicated in the Schedule to these regulations.
- (2) The Rock Oyster Farming Regulations 1964, Amendment No. 1, are hereby amended by omitting from the definition of "lot" in regulation 2 the words "4 gallons", and substituting the words "18 litres".
