ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Radio Regulations 1970, Amendment No. 17, and shall be read together with and deemed part of the Radio Regulations 1970* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of November 1986.

- 2. First Schedule—(1) The First Schedule to the principal regulations (as substituted by regulation 2 (1) of the Radio Regulations 1970, Amendment No. 15) is hereby amended—
 - (a) By omitting from item 16 the expression "\$45", and substituting the expression "\$65":
 - (b) By omitting from item 17 the expression "\$27.50", and substituting the expression "\$35":
 - (c) By omitting from item 18 the expression "\$2.29", and substituting the expression "\$2.92":
 - (d) By omitting from item 18 the expression "\$3.75", and substituting the expression "\$5.42".
- (2) Subclause (1) of this regulation shall apply where payment of a fee in respect of any television broadcast receiving station licence or any television hirer's licence is made in respect of a period commencing on or after the 1st day of November 1986, irrespective of the date of payment.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 November 1986, increase the fees payable for television broadcast receiving station licences and television hirer's licences as follows:

- (a) The fee for a colour television broadcast receiving station licence is increased from \$45 to \$65 per licensing year:
- (b) The fee for a monochrome television broadcast receiving station licence is increased from \$27.50 to \$35 per licensing year:
- (c) The fee for a television hirer's licence is increased from \$2.29 to \$2.92 per calendar month for each monochrome television set let out on hire, and from \$3.75 to \$5.42 per calendar month for each colour television set let out on hire.

These fees do not include the goods and services tax payable.
