**THE RADIO REGULATIONS 1970,
AMENDMENT NO. 5**

ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Radio Regulations 1970, Amendment No. 5, and shall be read together with and deemed part of the Radio Regulations 1970* (hereinafter referred to as the principal regulations).

(2) Except as otherwise provided, these regulations shall come into force on the 1st day of January 1975.

2. Person hiring colour television broadcast receiving apparatus—

(1) The principal regulations are hereby amended by revoking regulation 183A (as inserted by regulation 20 of the Radio Regulations 1970, Amendment No. 4).

(2) The principal regulations are hereby consequentially amended by revoking regulation 178 (2) (b) (as substituted by regulation 16 of the Radio Regulations 1970, Amendment No. 4).

(3) The Radio Regulations 1970, Amendment No. 4, are hereby consequentially amended by revoking regulation 20.

3. Fees payable in respect of licences issued under the principal regulations—(1) The First Schedule to the principal regulations is hereby amended by revoking clause 13 (as amended by regulation 17 (1) (b) of the Radio Regulations 1970, Amendment No. 1, and regulation 23 (1) of the Radio Regulations 1970, Amendment No. 4) and clause 13A (as inserted by regulation 23 (2) of the Radio Regulations 1970, Amendment No. 4), and substituting the following clauses:

“13. For a monochrome television broadcast receiving station licence	\$27.50 per annum.
“13A. For a colour television broadcast receiving station licence	\$45.00 per annum.

(2) The said First Schedule is hereby further amended by revoking paragraph (b) of clause 15 (as substituted by regulation 23 (3) of the Radio Regulations 1970, Amendment No. 4), and substituting the following paragraph:

“(b) Class II	\$2.29 per calendar month for each set of monochrome television broadcast receiving apparatus in the possession of the radio hirer:
		\$3.75 per calendar month for each set of colour television broadcast receiving apparatus in the possession of the radio hirer.”

(3) Regulation 17 (1) (b) of the Radio Regulations 1970, Amendment No. 1, and regulation 23 of the Radio Regulations 1970, Amendment No. 4, are hereby consequentially revoked.

(4) Subclause (1) of this regulation shall apply where payment of a fee in respect of any television broadcast receiving station licence is made in respect of a period commencing on or after the 1st day of January 1975 (irrespective of the date of payment).

(5) Subclause (2) of this regulation shall apply where payment of a fee in respect of any radio hirers licence Class II is made in respect of a period commencing on or after the 1st day of January 1975 (irrespective of the date of payment).

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Radio Regulations 1970 and are to come into force on 1 January 1975.

Regulation 2 revokes the requirement for persons hiring a colour television receiver and also possessing a monochrome television receiver to hold a colour television broadcast receiving station licence in their own right.

Regulation 3 increases the fees payable for television receiving and radio hirers licences as follows:

- (a) The fee for a monochrome television receiving licence is increased from \$20 to \$27.50 per licensing year:
- (b) The fee for a colour television receiving licence is increased from \$35 to \$45 per licensing year:
- (c) The fee for a radio hirers licence, Class II, is increased from \$1.66 to \$2.29 per calendar month for each monochrome television set in the possession of the hirer, and from \$2.91 to \$3.75 per calendar month for each colour television set in the possession of the hirer.
