THE RADIO REGULATIONS 1970, AMENDMENT NO. 9

ORDER IN COUNCIL

At the Government House at Wellington this 17th day of September 1979

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Radio Regulations 1970, Amendment No. 9, and shall be read together with and deemed part of the Radio Regulations 1970* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1979.

2. Classes of licences that may be granted—Regulation 11 of the principal regulations (as amended by regulation 3 (1) of the Radio Regulations 1970, Amendment No. 4) is hereby further amended by revoking paragraph (e), and substituting the following paragraph:

"(e) For radio dealers-radio dealers licence."

3. Classes of certificates—Regulation 69 (1) of the principal regulations is hereby amended by revoking paragraph (f).

4. Minimum age level—Regulation 76 of the principal regulations is amended by omitting from the first proviso the words "or a land radiotelephone operators certificate".

5. Examination for land radiotelephone operators certificate— The principal regulations are hereby further amended by revoking regulation 81.

6. Qualifications of operators of land mobile stations—The principal regulations are hereby further amended by revoking regulation 109.

7. Qualifications of operators of aeronautical stations and base stations—The principal regulations are hereby further amended by revoking regulation 118.

8. Qualifications of operator—The principal regulations are hereby further amended by revoking regulation 120.

9. Qualifications of operator—The principal regulations are hereby further amended by revoking regulation 133, and substituting the following regulation:

"133. (1) An experimental station shall be operated only by, or under the direct supervision and responsibility of, a person holding by way of minimum qualification, a radiotelegraph operators special certificate or a restricted radiotelephone operators certificate, as the case may require:

"Provided that in the case of universities and other scientific institutions the Director-General may, at his discretion, waive this requirement.

"(2) Notwithstanding anything in subclause (1) of this regulation, any person who, on the 1st day of October 1979, is the operator, or the person directly responsible for the operation, of an experimental station by virtue of his being the holder of a land radiotelephone operators certificate may continue in the capacity of operator, or person responsible for the operation, of the said experimental station for so long as the activities of the said experimental station are such that they would normally have been carried out by an operator, or under the control of a person, holding a land radiotelephone operators certificate but for the abolition of the land radiotelephone operators class of certificate."

10. Licence to be obtained—The principal regulations are hereby further amended by omitting from regulation 189 the words "of the appropriate class".

11. Scope of licences—The principal regulations are hereby further amended by revoking regulation 191, and substituting the following regulation:

"191. Radio dealers licences shall authorise the licensee to deal in radio apparatus at the fixed place of business named in the licence, either in person or by agent, but at no other fixed place of business; and shall authorise the licensee or his travelling representative to deal in radio apparatus from place to place not being fixed places of business, and to have radio apparatus in his possession for use by way of his business in maintaining and repairing such apparatus."

12. Fees payable in respect of licences issued under Radio Regulations 1970—(1) The principal regulations are hereby amended by revoking the First Schedule, and substituting the new First Schedule set out in the First Schedule to these regulations.

(2) The fees specified in the new First Schedule substituted by subclause (1) of this regulation shall apply in respect of licences issued on or after the 1st day of October 1979, irrespective of the date of payment.

13. Fees payable in respect of certificates issued under Part II of principal regulations—(1) The principal regulations are hereby amended by revoking the Second Schedule, and substituting the new Second Schedule set out in the Second Schedule to these regulations.

(2) The fees specified in the new Second Schedule referred to in subclause (1) of this regulation shall apply in respect of examinations or tests conducted on or after the 1st day of October 1979.

(3) The Radio Regulations 1970, Amendment No. 8 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Radio Regulations 1970, and come into force on 1 October 1979.

Regulation 2 amends the classes of licences that may be issued. Regulation 3 abolishes the land radiotelephone operators certificate.

Regulation 4 removes the reference to the land radiotelephone operators certificate.

Regulation 5 abolishes the examination for a land radiotelephone operators certificate.

Regulation 6 removes the requirement for any certificate to be held by operators of land mobile stations.

Regulation 7 removes the requirement for any certificates to be held by operators of aeronautical stations and base stations.

Regulation 9 provides for a minimum qualification to be held by operators of experimental stations and also permits existing operators of experimental stations to remain as such until the activities of the station are changed.

Regulation 10 removes the reference to the classification of dealers licences.

Regulation 11 provides for and sets conditions of use of a radio dealers licence.

Regulations 12 and 13 substitute revised Schedules of fees for certificates and licences.
