



THE RADIO REGULATIONS 1987, AMENDMENT NO. 6

ORDER IN COUNCIL

At Wellington this 15th day of October 1990

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Radiocommunications Act 1989, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Radio Regulations 1987, Amendment No. 6, and shall be read together with and deemed part of the Radio Regulations 1987* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of December 1990.

2. Interpretation—(1) Regulation 2 of the principal regulations is hereby amended by revoking the definition of the term “The Act”, and substituting the following definition:

“ ‘The Act’ means the Radiocommunications Act 1989:”.

(2) Regulation 2 of the principal regulations is hereby amended by revoking the definition of the term "Minister", and substituting the following definitions:

"'Minister' means the Minister of Communications:

"'VSAT' means satellite data networks using small aperture terminals in the fixed satellite service with 3 or more earth stations in one network."

3. Licences to be subject to terms, conditions, and restrictions—Regulation 14 (2) of the principal regulations is hereby amended by omitting the expression "23 (3)", and substituting the expression "111 (3)".

4. Fees—Regulation 43 of the principal regulations is hereby amended by revoking subclause (2), and substituting the following subclause:

"(2) The Secretary may waive, in whole or in part, the payment of any fee payable under these regulations where, in the opinion of the Secretary,—

"(a) The waiver is justified on humanitarian grounds; or

"(b) The nature of the use of the apparatus is such that no cost is incurred by the Secretary in relation to that apparatus."

5. Certificates of compliance—Regulation 37 (2) of the principal regulations is hereby amended by omitting the expression "subclause (2)", and substituting the expression "subclause (1)".

6. New Third Schedule—(1) The principal regulations are hereby amended by revoking the Third Schedule, and substituting the Third Schedule set out in the Schedule to these regulations.

(2) The Radio Regulations 1987, Amendment No. 4 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 December 1990, amend the Radio Regulations 1987 by—

- (a) Updating the definitions of “Act” and “Minister”;
- (b) Inserting a new definition of “VSAT”;
- (c) Updating and correcting 2 cross-references;
- (d) Providing that the Secretary of Commerce may only waive the payment of any fee in whole or in part on the grounds that—
 - (i) The waiver is justified on humanitarian grounds; or
 - (ii) The nature of the use of the apparatus is such that no cost is incurred by the Secretary in relation to that apparatus;
- (e) Substituting a new Third Schedule for the existing Third Schedule setting out the fees payable in respect of applications made, and licences and certificates issued, under the regulations.
