

# THE RADIOCOMMUNICATIONS (FEES) REGULATIONS 1990

### ORDER IN COUNCIL

At Wellington this 7th day of May 1990

THE RIGHT HON. J. HUNT PRESIDING IN COUNCIL

PURSUANT to section 135 of the Radiocommunications Act 1989, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Radiocommunications (Fees) Regulations 1990.
  - (2) These regulations shall come into force on the 1st day of June 1990.
- 2. Interpretation—(1) In these regulations, unless the context otherwise requires, "the Act" means the Radiocommunications Act 1989.
- (2) Expressions not defined in these regulations but defined in the Act have, in these regulations, the meanings so defined.
- **3. Fees**—The fees set out in the Schedule to these regulations shall be payable to the Registrar in respect of the matters specified in that Schedule.

**4. Goods and services tax included**—The fees prescribed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.
