ORDER IN COUNCIL

At Wellington this 5th day of March 1990

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 134 of the Radiocommunications Act 1989, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Radiocommunications (Forms) Regulations 1990.

(2) These regulations shall come into force on the 1st day of April 1990.

2. Interpretation—(1) In these regulations, unless the context otherwise requires, "the Act" means the Radiocommunications Act 1989.

(2) Expressions not defined in these regulations but defined in the Act have, in these regulations, the meanings so defined.

3. Forms—(1) The forms set out in the Schedule to these regulations are the forms to be used in respect of the matters under the Act to which those forms relate.

(2) Such variances may be made in any prescribed form as the circumstances of any particular case may require.

(3) Strict compliance with the prescribed forms is not necessary, and substantial compliance, or such compliance as the particular circumstances of the case allow, is sufficient.
