AMENDMENT NO. 1**

ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 135 of the Radiocommunications Act 1989, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Radiocommunications (Fees) Regulations 1993, Amendment No. 1, and shall be read together with and deemed part of the Radiocommunications (Fees) Regulations 1993* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 22nd of June 1995.

2. New Third Schedule substituted—The principal regulations are hereby amended by revoking the Third Schedule, and substituting the Third Schedule set out in the Schedule to these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 22 June 1995, amend the Radiocommunications (Fees) Regulations 1993. The regulations substitute a new Third Schedule, which sets out various fees payable by rightholders for the frequencies specified in their licences. New fees are prescribed for VHF Television Broadcasting frequencies. Other fees remain unchanged.
