**ORDER IN COUNCIL**

At the Government House at Wellington this 20th day of August 1979

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 9 of the Regulations Act 1936, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

**ORDER**

**1. Title and commencement**—(1) This order may be cited as the Regulations Revocation Order 1979.

(2) This order shall come into force on the 14th day after the date of its notification in the *Gazette*.

**2. Regulations, etc., revoked**—The regulations specified in the First Schedule hereto are hereby revoked.

**3. Regulations ceasing to have effect in New Zealand**—As from the commencement of this order the regulations specified in the Second Schedule hereto shall cease to have effect as part of the law of New Zealand.
