#### **EXPLANATORY NOTE**

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 11 February 1985, revokes the regulations that prescribe compulsory investment requirements in respect of building societies, finance companies, life insurance companies, superannuation funds, private savings banks, and trustee banks.
