



**THE ROTORUA TROUT FISHING REGULATIONS 1951,  
AMENDMENT NO. 6**

**ORDER IN COUNCIL**

At the Government Buildings at Wellington this 16th day of October 1956

Present:

THE RIGHT HON. S. G. HOLLAND PRESIDING IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

1. These regulations may be cited as the Rotorua Trout Fishing Regulations 1951, Amendment No. 6, and shall be read together with and deemed part of the Rotorua Trout Fishing Regulations 1951\* (hereinafter referred to as the principal regulations).

2. Subclause (1) of regulation 2 of the principal regulations is hereby amended by revoking paragraphs (b) and (c) of the definition of the term "open season" (as substituted by regulation 2 (1) of the Rotorua Trout Fishing Regulations 1951, Amendment No. 3), and substituting the following paragraphs:

"(b) In respect of all rivers and streams in the district flowing into lakes and the tributaries of those rivers and streams (but excepting the Ohau Channel and the Waikato River), the 1st day of December in any year to the 7th day of June in the year next following (both days inclusive):

"(c) In respect of all other waters in the district, the 1st day of November in any year to the 7th day of June in the year next following (both days inclusive):"

3. (1) Regulation 8 of the principal regulations is hereby amended by revoking subclause (1), and substituting the following subclause:

"(1) All licences shall be issued under the hand of an issuing officer, and, in the case of a whole season or weekly licence or a licence for more days than one, shall be generally in form 1 in the Second Schedule hereto, and, in the case of a one day licence, shall be generally in form 2 in that Schedule."

(2) The principal regulations are hereby amended by revoking the Second Schedule, and substituting the Second Schedule set out in the Schedule to these regulations.

4. (1) Regulation 23 of the principal regulations is hereby amended by adding the following proviso:

“Provided that the holder of such a licence for the time being current may during the open season in the Rotorua Trout Fishing District fish for, take, and kill trout in the waters or from the bank of that portion of the Waikato River that lies between the Huka Falls and the Waimahana Bridge at Mihi, subject to compliance by him with all the provisions of these regulations in force at that place at that time.”

(2) Regulation 21 of the principal regulations is hereby amended by inserting, before the words “No person”, the words “Except as provided in regulation 23 hereof”.

5. Regulation 28 of the principal regulations is hereby amended by inserting in paragraph (e), after the words “one hook”, the words “or any multiple hook”.

6. Subclause (3) of regulation 36 of the principal regulations (as substituted by regulation 2 (1) of the Rotorua Trout Fishing Regulations 1951, Amendment No. 4) is hereby amended by revoking paragraph (g), and substituting the following paragraph:

“(g) That portion of Lake Tarawera lying within 300 yards of the shore, or within 300 yards of a line between two markers painted orange and black and placed near the outlet of the lake, or between those markers and the falls in the Tarawera River approximately three miles downstream from the lake, and every stream, spring, or river flowing into the lake:”.

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

The effect of regulation 2 is to extend from 31 May to 7 June the duration of the open season in the waters described in the regulation.

Regulation 3 substitutes new forms of licences to fish in the Rotorua Trout Fishing District, one form being for monthly and weekly licences and licences for several days and the other for one day licences.

The effect of regulation 4 is that licences issued in the Taupo Trout Fishing District will also be available in the waters of the Waikato River between the Huka Falls and the Waimahana Bridge at Mihi. Those waters lie within the Rotorua Trout Fishing District.

The effect of regulation 5 is to prohibit the use of a multiple hook with any form of spoon bait.

Regulation 6 amends the description of the portion of Lake Tarawera and the Tarawera River in which local restrictions apply, the general effect of the amendment being that trolling will be permitted in Lake Tarawera except within 300 yards of the shore or within 300 yards of markers placed near the outlet of the lake.
