**THE RENTAL VEHICLE REGULATIONS 1939,
AMENDMENT NO. 1**

ORDER IN COUNCIL

At the Government House at Wellington, this 22nd day of

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Motor-vehicles Act, 1924, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Rental Vehicle Regulations 1939, Amendment No. 1.

2. These regulations shall be read together with and deemed part of the Rental Vehicle Regulations 1939* (hereinafter called the principal regulations).

3. These regulations shall come into force on the date of notification hereof in the *Gazette*.

4. Clause (3) of Regulation 1 of the principal regulations is hereby amended—

(a) By revoking the definition of “ the said declaration ” :

(b) By revoking the definition of “ rental service ” and “ the said service,” and substituting the following definition :—

“ ‘ Rental service ’ or ‘ the said service ’ means any service for the letting of a motor-vehicle on hire (otherwise than under a hire-purchase agreement) to a person who himself drives the motor-vehicle or provides a driver therefor.”

5. (1) Consequent on the provisions of subsection (1) of section 37 of the Transport Law Amendment Act, 1948 (hereinafter referred to as the Amendment Act), the Transport (Rental Vehicles) Notice 1939† is hereby revoked.

(2) All licences, appointments, warrants, and generally all acts of authority, permits, and applications, and all other documents, matters, acts, and things which originated or had effect under the Notice hereby revoked and are of continuing effect at the time of coming into force of these regulations shall enure for the purposes of the Amendment Act and these regulations as if they had originated thereunder, and shall, where necessary, be deemed to have so originated.

6. Clause (1) of Regulation 6 of the principal regulations is hereby amended by revoking the words " rental vehicles are hereby exempted," and substituting the words " Every rental vehicle, unless it is designed exclusively or principally for the carriage of goods and weighs with maximum load more than 2 tons, is hereby exempted ".

7. Clause (2) of Regulation 12 of the principal regulations is hereby revoked, and the following clause substituted :—

" (2) No person for the time being in charge of a rental vehicle shall use the vehicle or permit the vehicle to be used to carry a greater number of passengers or a greater gross weight of goods than is authorized for that vehicle in the inspection warrant for that vehicle.

8. Form T.L. 101 in the Table of Forms to the principal regulations is hereby revoked, and the following form substituted :—
