THE RENTAL VEHICLE REGULATIONS 1939, AMENDMENT NO. 4

PURSUANT to the Transport Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Rental Vehicle Regulations 1939, Amendment No. 4, and shall be read together with and deemed part of the Rental Vehicle Regulations 1939* (hereinafter referred to as the principal regulations).

2. (1) Regulation 1 of the principal regulations is hereby amended by revoking the definition of the expression "in form T.L." in

subclause (3).

(2) Regulation 2 of the principal regulations is hereby amended as follows:—

(a) By omitting from subclause (1) the words "in form T.L. 93", and substituting the words "in a form to be provided for the purpose by the Commissioner":

(b) By omitting from subclause (2) the words "in form T.L. 94".

(3) Regulation 3 of the principal regulations is hereby amended by omitting from subclause (1) the words "in form T.L. 95", and substituting the words "in a form to be provided for the purpose by the Commissioner".

(4) Regulation 4 of the principal regulations is hereby amended as follows:—

(a) By omitting from subclause (1) the words "in form T.L. 96", and substituting the words "in a form to be provided for the purpose by the Commissioner":

(b) By omitting from subclause (3) the words "in form T.L. 98", and substituting the words "in a form to be provided for the

purpose by the Commissioner ".

(5) Regulation 5 of the principal regulations is hereby amended by omitting from subclause (1) the words "in form T.L. 99", and substituting the words "in a form to be provided for the purpose by the Commissioner ".

(6) Regulation 8 of the principal regulations is hereby amended by omitting from subclause (1) the words "in form T.L. 16", and substituting the words "in a form to be provided for the purpose by the

Commissioner ".

(7) The principal regulations are hereby amended by revoking the

Third Schedule.

3. Regulation 2 of the principal regulations is hereby further amended by omitting from subclause (1) the words "and shall be

accompanied by the respective fee ".

4. (1) The principal regulations are hereby amended by revoking the Second Schedule (as enacted by regulation 10 of the Rental Vehicle Regulations 1939, Amendment No. 3), and substituting the following Schedule:

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

The principal regulations require the forms specified in the Third Schedule to be used for the purposes of applications, &c., under those regulations. The purpose of regulation 2 of these regulations is to enable the Commissioner of Transport to prescribe the forms.

Regulation 3 abolishes the requirement that the annual licence fee is to be

paid when application for a licence is made.

Regulation 4 prescribes a new scale of fees. The only change made is that the annual licence fee is reduced from £5 10s. to £3.
