



**THE SECURITIES ACT (LOCAL AUTHORITY AND OTHER
VENTURE CAPITAL SCHEMES) EXEMPTION NOTICE 1994,
AMENDMENT NO. 5**

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Securities Act (Local Authority and Other Venture Capital Schemes) Exemption Notice 1994, Amendment No. 5, and shall be read together with and deemed part of the Securities Act (Local Authority and Other Venture Capital Schemes) Exemption Notice 1994* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. Schedule amended—The principal notice is hereby amended by revoking the Schedule thereto (as substituted by the Securities Act (Local Authority and Other Venture Capital Schemes) Exemption Notice 1994, Amendment No. 1 and amended by the Securities Act (Local Authority and Other Venture Capital Schemes) Exemption Notice 1994, Amendment No. 2 and the Securities Act (Local Authority and Other Venture Capital Schemes) Exemption Notice 1994, Amendment No. 4), and substituting the Schedule set out in the First Schedule to this notice.

3. Revocations—The notices specified in the Second Schedule to this notice are hereby consequentially revoked.
