

THE SECURITIES ACT (COMMERCIAL BILL DEALERS) EXEMPTION NOTICE 1983, AMENDMENT NO. 3

Pursuant to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Securities Act (Commercial Bill Dealers) Exemption Notice 1983, Amendment No. 3, and shall be read together with and deemed part of the Securities Act (Commercial Bill Dealers) Exemption Notice 1983* (hereinafter referred to as the principal notice).
 - (2) This notice shall come into force on the 1st day of February 1984.
- 2. Temporary exemption from certain provisions of the Securities Act 1978—Clause 5 of the principal notice is hereby amended by omitting the words "1 February 1984", and substituting the words "1 April 1984".
- **3.** New Schedule substituted—(1) The principal notice is hereby amended by revoking the Schedule thereto (as substituted by the Securities Act (Commercial Bill Dealers) Exemption Notice 1983, Amendment No. 1 and amended by the Securities Act (Commercial Bill Dealers) Exemption Notice 1983, Amendment No. 2), and substituting the Schedule set out in the Schedule to this notice.
- (2) The Securities Act (Commercial Bill Dealers) Exemption Notice 1983, Amendment No. 1 and the Securities Act (Commercial Bill Dealers) Exemption Notice 1983, Amendment No. 2 are hereby revoked.

EXPLANATORY NOTE

This notice comes into force on 1 February 1984.

Clause 2 exempts a dealer from compliance with certain provisions of the Act in respect of any offer of debt securities made before 1 April 1984.

 ${\it Clause 3}$ adds 1 additional person to the list of named commercial bill dealers in the Schedule to the Securities Act (Commercial Bill Dealers) Exemption Notice 1983.
