**THE SECURITIES ACT (TRUSTEE BANKS)  
EXEMPTION NOTICE 1987**

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Securities Act (Trustee Banks) Exemption Notice 1987.

(2) This notice shall come into force on the 1st day of April 1987.

**2. Interpretation**—(1) In this notice, unless the context otherwise requires,—

“The Act” means the Securities Act 1978:

“Trustee bank” means a trustee bank established under the Trustee Banks Act 1983.

(2) Any term or expression which is not defined in this notice, but which is defined in the Act shall have the meaning given to it by the Act.

**3. Trustee banks temporarily exempt from compliance with certain provisions of the Securities Act 1978**—Every trustee bank, and every person acting on its behalf, is exempted from compliance with the provisions of sections 37, 37A, 38 (a) to (c) and 39 to 44 of the Act in respect of any offer of debt securities made before the 1st day of October 1987 of which that trustee bank is the issuer.

EXPLANATORY NOTE

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice, which comes into force on 1 April 1987, temporarily exempts trustee banks from compliance with certain provisions of the Securities Act 1978 in respect of offers of debt securities.
