

## THE SECURITIES ACT (ANZ BANKING GROUP (NEW ZEALAND) LIMITED) EXEMPTION NOTICE (NO. 4) 1990

Pursuant to the Securities Act 1978, the Securities Commission gives the following notice.

## NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Securities Act (ANZ Banking Group (New Zealand) Limited) Exemption Notice (No. 4) 1990.
- (2) This notice shall come into force on the day after the date of its notification in the Gazette.
- **2.** Interpretation—(1) In this notice, unless the context otherwise requires,—

"The Act" means the Securities Act 1978:

- "The Company" means ANZ Banking Group (New Zealand) Limited.
- (2) In this notice a reference to an offer of debt securities made by the Company shall be construed as a reference to an offer of debt securities in respect of which the Company is exempted from compliance with any provisions of the Act or the Securities Regulations 1983 by the Securities Act (Banks) Exemption Notice 1988.
- (3) Any term or expression which is not defined in this notice, but which is defined in the Act, shall have the meaning given to it by the Act.
- 3. ANZ Banking Group (New Zealand) Limited temporarily exempted from section 37A (1) (e) of the Securities Act 1978—(1) Subject to subclause (2) of this clause, the Company, and every person acting on its behalf, is exempted from compliance with the provisions of section 37A (1) (e) of the Act in respect of any offer of debt securities made by the Company before the 1st day of October 1990.
- (2) The exemption granted by subclause (1) of this clause is subject to the condition that no allotment of any security to which that subclause applies shall be made if the date of allotment would be more than 12 months after the date of the most recent balance sheet set out, or attached to, or referred to, in accordance with regulations made under the Act, in the registered prospectus relating to the security.

4. **Revocation**—The Securities Act (ANZ Banking Group (New Zealand) Limited) Exemption Notice (No. 3) 1990\* is hereby revoked.

## EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice replaces the Securities Act (ANZ Banking Group (New Zealand) Limited) Exemption Notice (No. 3) 1990, and extends, subject to conditions, the time during which ANZ Banking Group (New Zealand) Limited may allot debt securities in the case of offers made before 1 October 1990 from not more than 11 months to not more than 12 months after the date of the most recent balance sheet contained in the registered prospectus relating to those securities.
