THE SECURITIES ACT (GOODMAN FIELDER WATTIE LIMITED) EXEMPTION NOTICE 1990

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Securities Act (Goodman Fielder Wattie Limited) Exemption Notice 1990.
- (2) This notice shall come into force on the day after the date of its notification in the Gazette.
- **2. Interpretation**—(1) In this notice, unless the context otherwise requires,—
 - "The Act" means the Securities Amendment Act 1988:
 - "The Company" means Goodman Fielder Wattie Limited, a company incorporated under the laws of the Commonwealth of Australia.
- (2) Any term or expression which is not defined in this notice, but which is defined in the Act or in the Securities Act 1978, shall have the meaning given to it by the Act or the Securities Act 1978.
- 3. Goodman Fielder Wattie Limited temporarily exempted from compliance with section 26 (2) of the Securities Amendment Act 1988—(1) Subject to subclause (2) of this clause, the Company and every person acting on its behalf, is exempted from compliance with the provisions of section 26 (2) of the Act in respect of the year 1990.
- (2) The exemption granted by subclause (1) of this clause is subject to the condition that the Company shall, not later than the 31st day of October 1990, send to every holder of its voting securities resident in New Zealand a copy of its balance sheet laid or to be laid before the Company in general meeting which is accompanied by a note which states—
 - (a) The names of all persons who, according to the file kept by the Company under section 25 of the Act, are substantial security holders of the Company as at a date not earlier than 3 months before the balance sheet is laid before the Company in general meeting; and
 - (b) The number of voting securities of the Company in which, according to the file, each substantial security holder has a relevant interest as at that date; and

(c) The total number of issued voting securities of the Company as at that date.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice exempts Goodman Fielder Wattie Limited from compliance with section 26 (2) of the Securities Amendment Act 1988 in respect of the year 1990 subject to the condition that, before 1 November 1990, it sends to holders of its voting securities resident in New Zealand certain information about relevant interests in, and the number of, its issued voting securities.
