

# THE SOUTHLAND AREA HEALTH DISTRICT (TRIENNIAL GENERAL ELECTION AND BOUNDARIES) ORDER 1989

#### ORDER IN COUNCIL

At Wellington this 17th day of July 1989

## Present:

#### HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 5A of the Area Health Boards Act 1983 (as inserted by section 4 of the Area Health Boards Amendment Act 1989) and to subsections (3), (4), and (4A) of section 8 of the Area Health Boards Act 1983 (as amended by section 5 of the Area Health Boards Amendment Act 1989 and by section 5 of the Area Health Boards Amendment Act (No. 2) 1989), His Excellency the Governor-General, acting on the advice of the Minister of Health, and by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

- 1. Title and commencement—(1) This order may be cited as the Southland Area Health District (Triennial General Election and Boundaries) Order 1989.
- (2) Except as provided in clause 8 (2) of this order, this order shall come into force on the 18th day of July 1989.
- 2. Boundaries for triennial general election—It is hereby declared that, for the purposes of the triennial general election of members of local authorities to be held on the 14th day of October 1989 (as required by section 4 of the Local Elections and Polls Act 1976), the boundaries of the Southland Area Health District shall be deemed to be the boundaries of the land included within the Invercargill District, the Gore District, the Southland District, and the Queenstown West Ward, the Queenstown East Ward, the Arrowtown Ward, and the Wakatipu Ward of the Queenstown-Lakes District (being districts, or wards of districts, of territorial authorities named in the First Schedule to the Local Government Act 1974 (as substituted by clause 2 of the Local Government Act First Schedule Order (No. 2) 1989\*)).
- **3. Boundaries on 58th day after polling day**—It is hereby declared that, on the 58th day after polling day for the triennial general election referred to in clause 2 of this order, the boundaries declared by that clause shall become the boundaries of the Southland Area Health District.
- **4. Constituent districts**—It is hereby declared that, for the purposes of the triennial general election referred to in clause 2 of this order,—
  - (a) The area comprising the wards of the Invercargill District known as the Northern Ward, the Gladstone Ward, the Glengarry Ward, and the Central Ward shall be a constituent district of the Southland Area Health District; and
  - (b) The area comprising the wards of the Invercargill District known as the Strathern Ward, the Kew Ward, the Bluff Ward, the Bush Ward, and the Otatara Ward shall be a constituent district of the Southland Area Health District; and
  - (c) The Gore District shall be a constituent district of the Southland Area Health District; and
  - (d) The area comprising the Te Anau Ward and the Tuatapere Ward of Southland District shall be a constituent district of the Southland Area Health District; and
  - (e) The area comprising the Otautau Ward, the Riverton Ward, the Wallacetown Ward, the Winton Ward, the Toetoes Ward, the Waihopai Ward, the Te Tipua Ward, and the Stewart Island Ward of Southland District shall be a constituent district of the Southland Area Health District; and
  - (f) The wards of the Southland District known as the Five Rivers Ward and the Wakaia Ward, and the wards of the Queenstown-Lakes District known as the Queenstown West Ward, the Queenstown East Ward, the Arrowtown Ward, and the Wakatipu Ward shall each be a constituent district of the Southland Area Health District.

- **5. Number of representatives of constituent districts**—The number of representatives on the Southland Area Health Board of each constituent district declared by clause 4 of this order (not being a constituent district to which clause 6 of this order applies) shall be as specified in the Schedule to this order.
- **6. Combined district**—(1) For the purpose of the election of representatives on the Southland Area Health Board, the constituent districts declared by clause 4 (f) of this order are hereby combined into a combined district.
- (2) The number of members to be elected in common as the representatives of that combined district shall be as specified in the Schedule to this order.
- **7. Conduct of elections**—(1) For the purpose of the conduct of elections held within the constituent district declared by clause 4 (a) of this order,—
  - (a) The Invercargill City Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
  - (b) The Invercargill District Council (as constituted by the Local Government (Southland Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- (2) For the purpose of the conduct of elections held within the constituent district declared by clause 4 (b) of this order,—
  - (a) The Invercargill City Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
  - (b) The Invercargill District Council (as constituted by the Local Government (Southland Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- (3) For the purpose of the conduct of elections held within the constituent district declared by clause 4 (d) of this order,—
  - (a) The Southland County Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct elections held within that constituent district before the 1st day of November 1989; and
  - (b) The Southland District Council (as constituted by the Local Government (Southland Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- (4) For the purpose of the conduct of elections held within the constituent district declared by clause 4 (e) of this order,—
  - (a) The Southland County Council (as constituted on the commencement of this clause) is hereby selected and appointed to conduct

elections held within that constituent district before the 1st day of November 1989; and

- (b) The Southland District Council (as constituted by the Local Government (Southland Region) Reorganisation Order 1989) is hereby selected and appointed to conduct elections held within that constituent district on or after the 1st day of November 1989.
- (5) For the purpose of the conduct of elections held before the 1st day of November 1989 within the combined district created by clause 6 (1) of this order, the Queenstown-Lakes District Council (as constituted on the commencement of this clause) is hereby selected and appointed to be the principal local authority of the combined district.
- (6) For the purpose of the conduct of elections held on or after the 1st day of November 1989 within the combined district created by clause 6 (1) of this order, the Queenstown-Lakes District Council (as constituted by the Local Government (Otago Region) Reorganisation Order 1989) is hereby selected and appointed to be the principal local authority of the combined district.
- **8. Revocations**—(1) Clauses 3 to 5 of, and the Schedule to, the Southland Area Health District Order 1988\* are hereby revoked.
  - (2) This clause shall come into force on the 11th day of December 1989.

# **EXPLANATORY NOTE**

This note is not part of the order, but is intended to indicate its general effect.

#### This order-

- (a) Declares the boundaries that are to be deemed to be the boundaries of the Southland Area Health District for the purposes of the triennial general election of members of local authorities to be held on 14 October 1989; and
- (b) Declares the areas that are to be constituent districts of the Southland Area Health District for the purposes of that election.
- On 11 December 1989 (the 58th day after polling day for that election) the boundaries so declared will become the boundaries of the Southland Area Health District and the constituent districts so declared will become constituent districts of that area health district.

Some constituent districts are combined into a combined district for the purpose of the election of representatives on the area health board.
