



**THE SECURITIES ACT (RETIREMENT HOMES) EXEMPTION
NOTICE 1993, AMENDMENT NO. 12**

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 12, and shall be read together with and deemed part of the Securities Act (Retirement Homes) Exemption Notice 1993* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. First Schedule amended—The First Schedule to the principal notice (as substituted by the Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 10 and amended by the Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 11) is hereby amended by—

- (a) Inserting, in its appropriate alphabetical order, the name “Clare House Lifecare Company Limited”;
- (b) Omitting the name “Omokoroa Retirement Village Limited”, and substituting the name “Omokoroa Country Estate Limited”.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.
