



**THE SECURITIES ACT (RETIREMENT HOMES) EXEMPTION
NOTICE 1993, AMENDMENT NO. 2**

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 2, and shall be read together with and deemed part of the Securities Act (Retirement Homes) Exemption Notice 1993* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. New First and Second Schedules to principal notice—(1) The principal notice is hereby amended by revoking the First and Second Schedules thereto (as amended by the Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 1), and substituting the First and Second Schedules set out in the Schedule to this notice.

(2) The Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 1 is hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the *Gazette*, adds M & R Cooper Family Trust to the First Schedule and Baptist Union of New Zealand and Gracelands Retirement Village Limited to the First and Second Schedules to the Securities Act (Retirement Homes) Exemption Notice 1993.

The First Schedule lists the persons to whom the exemption from section 37A (1) (e) of the Securities Act 1978 applies. The Second Schedule specifies a number of such persons in respect of which that exemption is subject to an additional condition.
