



**THE SECURITIES ACT (RETIREMENT HOMES) EXEMPTION
NOTICE 1993, AMENDMENT NO. 4**

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 4, and shall be read together with and deemed part of the Securities Act (Retirement Homes) Exemption Notice 1993* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. New First and Second Schedules to principal notice—(1) The principal notice is hereby amended by revoking the First and Second Schedules thereto (as substituted by the Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 2 and amended by the Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 3), and substituting the First and Second Schedules set out in the Schedule to this notice.

(2) The Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 2 and the Securities Act (Retirement Homes) Exemption Notice 1993, Amendment No. 3 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.
