



**THE SECURITIES ACT (CONTINUOUS ISSUES) EXEMPTION

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Securities Act (Continuous Issues) Exemption Notice (No. 3) 1987, Amendment No. 8, and shall be read together with and deemed part of the Securities Act (Continuous Issues) Exemption Notice (No. 3) 1987* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. New First Schedule substituted—The principal notice is hereby amended by revoking the First Schedule thereto (as substituted by the Securities Act (Continuous Issues) Exemption Notice (No. 3) 1987, Amendment No. 7), and substituting the First Schedule set out in the Schedule to this Notice.

3. Revocation—The Securities Act (Continuous Issues) Exemption Notice (No. 3) 1987, Amendment No. 7 is hereby revoked.
