**THE SCIENTIFIC AND INDUSTRIAL RESEARCH
(ALLOWANCES) REGULATIONS 1950**

ORDER IN COUNCIL

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Scientific and Industrial Research Act, 1926, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Scientific and Industrial Research (Allowances) Regulations 1950.
2. In these regulations, unless the context otherwise requires,—
 - “Committee” means any Committee appointed by the Council pursuant to the said Act :
 - “Council” means the Council of Scientific and Industrial Research constituted by the said Act :
 - “Member” means a member of the Council or of any Committee, not being a person in the service of the Crown :
 - “Minister” means the Minister of the Crown for the time being charged with the administration of the Scientific and Industrial Research Act, 1926.

ALLOWANCES FOR SERVICES

3. (1) There shall be paid to the Chairman of the Council an annual allowance, to be approved by the Minister, not exceeding £100 per annum.
- (2) There shall be paid to each member of the Council other than the Chairman an annual allowance, to be approved by the Minister, not exceeding £50 per annum.
- (3) Nothing in this regulation shall apply to any person who is in the service of the Crown, or shall entitle any person to an allowance by virtue only of the fact that he is a member of the Committee.

TRAVELLING-EXPENSES AND SUBSISTENCE ALLOWANCES

4. (1) The Travelling-allowance Regulations 1949* shall apply to and be deemed to be incorporated in these regulations so as to relate to the Council and its members and any member of a Committee.

(2) The subsistence allowance referred to in Regulation 5 of the Travelling-allowance Regulations 1949 shall be at the rate of £1 15s. a day :

Provided that where a member is entitled to a subsistence allowance and occupies a hotel room for one night only, an additional amount of 2s. may be paid to that member.

(3) The mileage allowance referred to in Regulation 13 of the Travelling-allowance Regulations 1949 shall be calculated in accordance with the following table :—

Horse-power of Car.	Mileage Allowance.
Not exceeding 9½	5½d. a mile.
Exceeding 9½ but not exceeding 14½	6¼d. a mile.
Over 14½	7d. a mile.

(4) Garage expenses payable to a member pursuant to this regulation shall not exceed 2s. 6d. for every night on which any such expenses are incurred.
