



**THE SECURITIES ACT (UNITED KINGDOM ISSUERS EMPLOYEE
SHARE PURCHASE SCHEMES) EXEMPTION NOTICE 1991,
AMENDMENT NO. 2**

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice 1991, Amendment No. 2, and shall be read together with and deemed part of the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice 1991* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. New First Schedule substituted—The principal notice is hereby amended by revoking the First Schedule (as amended by the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice 1991, Amendment No. 1), and substituting the First Schedule set out in the Schedule to this notice.

3. Revocation—The Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice 1991, Amendment No. 1 is hereby consequentially revoked.
