

THE SECURITIES ACT (UNITED KINGDOM ISSUERS EMPLOYEE SHARE PURCHASE SCHEMES) EXEMPTION NOTICE (NO. 2) 1992, AMENDMENT NO. 10

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992, Amendment No. 10, and shall be read together with and deemed part of the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its

notification in the Gazette.

2. Schedule amended—The Schedule to the principal notice (as substituted by the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992, Amendment No. 8 and amended by the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992, Amendment No. 9), is hereby amended by inserting in the first column, in its appropriate alphabetical order, the name "Thorn Lighting Group plc" and opposite that name in the second and third columns respectively, the names "Halifax Building Society" and "Thorn Lighting (N.Z.) Limited".

EXPLANATORY NOTE
