

# THE SECURITIES ACT (UNITED KINGDOM ISSUERS EMPLOYEE SHARE PURCHASE SCHEMES) EXEMPTION NOTICE (NO. 2) 1992, AMENDMENT NO. 8

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

#### **NOTICE**

- 1. Title and commencement—(1) This notice may be cited as the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992, Amendment No. 8, and shall be read together with and deemed part of the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992\* (hereinafter referred to as the principal notice).
- (2) This notice shall come into force on the day after the date of its notification in the Gazette.
- 2. New Schedule substituted—The principal notice is hereby amended by revoking the Schedule thereto (as substituted by the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992, Amendment No. 6 and amended by the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992, Amendment No. 7), and substituting the Schedule set out in the Schedule to this notice.
- **3. Revocations**—The Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992, Amendment No. 6 and the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992, Amendment No. 7 are hereby consequentially revoked.

#### EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the Gazette, adds additional designated issuers and savings scheme issuers to the Schedule to the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992. The notice also omits the name PA Management Consultants Limited from the Schedule and substitutes the name PA Consulting Group Limited as the result of a change of name.
