1. Title and commencement—(1) This notice may be cited as the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992, Amendment No. 6, and shall be read together with and deemed part of the Securities Act (United Kingdom Issuers Employee Share Purchase Schemes) Exemption Notice (No. 2) 1992* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2.
