**THE SEA-FISHERIES (BOATS AND LICENCES)
REGULATIONS 1945, AMENDMENT NO. 1**

THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL

PURSUANT to the Fisheries Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Sea-fisheries (Boats and Licences) Regulations 1945, Amendment No. 1.

2. These regulations shall be read together with and deemed part of the Sea-fisheries (Boats and Licences) Regulations 1945* (hereinafter called the principal regulations).

3. The principal regulations are amended by inserting, next following Regulation 24, the following heading and regulation :—

“ Implied Conditions may be varied or negatived ”

“ 24A. Notwithstanding anything to the contrary in Regulation 23 (all licences), or in Regulations 29 (boat licences), 33 (crew licences), 36 (fishermen’s licences), and 37 (temporary licences), any conditions declared by these regulations to be implied in any licence may therein be expressly varied or negatived.”

4. Clause (2) of Regulation 26 of the principal regulations is amended by revoking the words “ For the purposes of this regulation ”, and substituting the words “ For the purposes of these regulations.”

5. Regulation 36 of the principal regulations is amended by adding, after paragraph (d), the following paragraph :—

“ (e) That the holder will take no toheroas for purposes of sale.”

6. Form No. 1 in the Second Schedule to the principal regulations is amended by revoking the word “ length ” heading the sixth main column, and substituting the words “ overall length.”

7. Form No. 2 in the Second Schedule to the principal regulations is amended—

- (a) By adding, next after the word “trawling” in item 5, the words “cray-pots”;
- (b) By revoking the words “Strike out which does not apply”, and substituting the words “strike out words which do not apply and insert any method proposed to be used if not included in foregoing list”; and
- (c) By revoking the word “length” in item 6, and substituting the words “overall length.”

8. Form No. 3 of the Second Schedule to the principal regulations is amended by revoking the word “length” in item No. 6, and substituting the words “overall length”.

9. Form No. 1 of the Third Schedule to the principal regulations is amended—

- (a) By adding the words “cray-pots” next after the word “trawling” in item 6; and
- (b) By adding in brackets following the said item 6 the words “[strike out words which do not apply and insert any method proposed to be used if not included in foregoing list]”.
