PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

**NOTICE**

**1. Title and commencement**—(1) This notice may be cited as the Securities Act (Inspection of Registers) Exemption Notice 1985, Amendment No. 4, and shall be read together with and deemed part of the Securities Act (Inspection of Registers) Exemption Notice 1985\* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the 1st day of October 1987.

**2. New Schedule substituted**—The principal notice is hereby amended by revoking the Schedule thereto (as substituted by the Securities Act (Inspection of Registers) Exemption Notice 1985, Amendment No. 3), and substituting the Schedule set out in the Schedule to this notice.

**3. Revocation**—The Securities Act (Inspection of Registers) Exemption Notice 1985, Amendment No. 3 is hereby revoked.

## EXPLANATORY NOTE

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice, which comes into force on 1 October 1987, omits the names Barclays New Zealand Limited, Broadbank Corporation Limited, and Indosuez New Zealand Limited from the list of designated issuers in the Schedule to the Securities Act (Inspection of Registers) Exemption Notice 1985. As registered banks these companies are exempted from compliance with section 52 of the Securities Act 1978 by virtue of section 5 (2) of the Securities Act 1978 as amended by the Reserve Bank of New Zealand Amendment Act 1986.

The notice deletes the name Development Finance Corporation of New Zealand and substitutes the name DFC New Zealand Limited in consequence of the transfer pursuant to the Development Finance Corporation of New Zealand Act 1986 of the undertaking of the Development Finance Corporation of New Zealand to that company.
